



Revenue in Last 5 Years 過往五年收益




Gross Profit (Loss) and Gross Profit (Loss) Margin in Last 5 Years

Chairman's Statement 主席報告



In 2018, the situation of international politics and the world economy was unstable. The intensified geopolitical differences and the revival of global trade protectionism and the conceptions of anti-globalisation in turn constituting a multilateral trade conflict centered by the China-US trade dispute. Although the overall China's economy was stable, on the one hand, it faced the pressure from economic transformation and upgrading. On the other hand, it was required to properly handle and prevent the potential systemic risks brought by unreasonable debt and economic structures. At the same time, the Chinese government was firmly committed to promote two arduous programmes, namely "to address overcapacity" and "the battle to defend the blue sky", and introduced new recycling import policy. The abovementioned changes have brought challenges and pressure to the global recycling industry.

In a year with twists and turns, we marched forward despite all the pressure and difficulties. Fortunately, the tendency of the recycling industry and economy will not be changed by short-term events. Countries worldwide still scrupulously abided by their undertakings to climate change and the theme on promoting sustainable development. In China, the government has formulated national development strategy to give prominence to the concept of protecting green hills and clear waters, strengthening circular economy, and green development. In 2018, the recycling industry has gained attention locally and globally, and the position of the recycling industry has elevated.

Chiho Environmental Group Limited (the "Company") and its subsidiaries (the "Group", "we" or "our") has considered the rising regional trade protectionism when formulating our strategies, makes best use of the situation, adjusts our business layout and strategic planning in a timely manner to adapt to the new situation. The Group is mainly engaged in metal recycling and processing of ferrous and non-ferrous metal such as steel, copper and aluminum. The metals produced by the Company is mainly sold in local markets, which means that recycled steel produced in Europe is sold in Europe and that produced in America is mainly sold in America. The high tariff imposed by Europe and America on the lower priced steel from China to protect local steel industries has indirectly helped local recycled steel industries, and from which the Group has benefited. However, the rising trade protectionism will harm economic growth in general. The uncertainty brought by trade disputes has a ripple effect across the economy which in turn softened the demand from customers.

二零一八年，全球政經環境風雲變幻，世界地緣政治分歧不斷加劇，全球貿易保護主義和反全球化思維不斷抬頭，並引發了以中美貿易戰為首的全球多邊貿易爭端。中國雖然總體企穩，但一方面面臨經濟轉型升級的壓力，另一方面需要妥善處理和防範債務和經濟結構不合理帶來的潛在系統性風險。同時，中國政府堅決的推行「化解過剩產能」和「藍天保衛戰」兩項艱巨的任務，並出台了針對回收資源進口的新政策。以上的變化，給全球再生行業產業帶來挑戰和壓力。

身處這樣的轉折年，大家承壓前行。但再生行業和循環經濟的趨勢性是不會因為短期事件而動搖的。全球恪守氣候變化承諾以及推進可持續發展的主旋律沒有變；中國國內，守護綠水青山，強化循環經濟，綠色發展的理念被訂立為國家發展戰略，並放在首要位置。在二零一八年再生行業受到的國際國內關注比以前更多，行業地位更加凸顯。

齊合環保集團有限公司（「本公司」）及其子公司（「本集團」、「我們」）在策略上考慮到地域性貿易保護主義的抬頭的情況，因勢利導，及時調整業務佈局和戰略謀劃，以適應新形勢。我們的營業務是金屬回收，加工和處理，而產品主要是以鋼、銅、鋁為主的各類黑色和有色金屬。公司產出的回收鋼主要在當地市場出售，即歐洲產生的回收鋼在歐洲消化，美洲的回收鋼主要在美洲消化。歐美對較為廉價的中國鋼材徵收高額關稅以保護本土的鋼鐵產業，間接幫助了當地的回收鋼鐵行業，本集團因此從中受益。但是貿易保護主義的持有升溫畢竟不利於整體經濟的增長。我們看到了消費者信心因貿易爭端導致的不確定性而下降，間接影響了實體經濟活力和需求端的疲軟。

Although the US government has withdrawn from the Paris climate agreement unilaterally, governments in the Eurozone are consistent with each other to defend this agreement. The European Commission is working on legislation to require members of the European Union to meet the emission reduction target under the Paris climate agreement. The carbon tax issue in Europe has been raised for several times since 2017, imposing considerable pressure on steel factories. Many of our customers are steel companies in Europe and America. It is expected that steel mills in Europe will accelerate the process of converting their production (using blast furnaces) to short process (using electric arc furnaces). Electric arc furnace short process steelmaking uses recycled steel as its main raw materials. On the other hand, blast furnace steelmaking requires iron ore, coking coal and steel scrap as raw materials. We believe that this will increase the demand for recycled steel in Europe. In China, being the world's largest steel producer, it is vigorously promoting energy conservation and emission reduction to defend the blue sky, as such the production capacity of blast furnace enterprises has been limited to some extent. Domestic large steel mills also vigorously improving steel capacity by converting to electric arc furnace steelmaking. Therefore, we expect a significant increase in the demand for steel scrap.

The main product of our business in China is recycled copper. Copper price is the barometer of the economy, and China is the largest consumer of copper in the world. The slowdown of Chinese economy was triggered by various external factors. To stimulate economic growth, the Chinese government increased its investment in infrastructure construction, which is beneficial to copper demand. However, softer consumer demand and the sluggish construction industry do not bode well for the copper demand. Facing high market uncertainty, we will try our best to maintain a high turnover to avoid risks. Nevertheless, the Group will continue to expand the high value copper recycling business, as China is highly dependent on imported copper and regardless of power grids, cartridge cases, circuit boards or for new energy vehicles, there all exist tremendous demand for copper. The Group will supply the PRC market with high-grade recycled copper processed in the processing yards in Europe and North America and yards to be set up in Southeast Asia. With the rising usage of copper in China, there will be growth in copper scrap. In addition, the domestic recycling industry is constantly integrating and consolidating, there will be more copper scraps recycled through proper and legitimate channels. We will take advantage of this opportunity to expand our market share of local scrap copper recycling by leveraging our industry and market experience accumulated over the years.

雖然美國政府單方面退出了巴黎氣候協議，但是歐盟區國家捍衛該協議的決心很堅決立場一致。歐盟委員會在研究立法要求成員國達到巴黎氣候協議的減排目標。歐洲的碳排放稅已經從二零一七年的低位漲了幾倍，這對鋼廠的成本形成了不小壓力。本集團的客戶有不少是歐美的鋼鐵企業。歐洲鋼廠從長流程（採用高爐的煉鋼方式）轉向短流程（採用電爐煉鋼的方式）的趨勢應該會加快。因為短流程煉鋼的電爐以回收鋼為原料，而高爐則以鐵礦石、焦煤和廢鋼為主原料。我們認為這個趨勢會加大歐洲市場對回收鋼的需求。在全球最大的鋼鐵生產國—中國，目前國家大力推動節能減排和藍天保衛行動，高爐企業產能均被不同程度限產。目前國內大鋼廠也在大力發展電爐煉鋼產能。因此對廢鋼的需求會出現顯著提升。

本集團在中國國內主要產品是回收銅。銅價是一個重要的經濟溫度計，而中國是最大的銅消費國。中國經濟的放緩有許多內外部因素。為了激活經濟，政府在基礎設施建設方面加大投入，這對銅的需求還是比較有利。但是消費產品和建築業的疲軟則不利於銅價。在市場不確定性比較高的情況下，我們將盡力維持高周轉率，規避風險。總體而言，本集團還是會加大價值高的回收銅業務，畢竟中國對進口銅的依賴度非常高，而且不管是電網、彈殼、電路板還是新能源汽車都需要大量的銅。本集團會利用歐美基地和未來在東南亞的工廠回收和處理高品位的回收銅來供應國內市場。同時，一方面國內不繼攀升的銅需求也將帶來不斷增長的銅廢料的產出；另一方面國內的再生行業也不斷在行業整合，提檔升級。因此將會有更多的廢銅出現，並流入到合規合法的渠道來再生。借此契機，我們也將運用自身在國內多年積累的行業經驗和市場經驗，逐步加大在國內本地廢銅回收的份額。

Chairman's Statement 主席報告

2018 marked an important year for the recycled metal industry in China. The import of the Category 7 solid wastes, including scrap motors and cables, has been completely banned at the end of 2018. The new policy has brought great uncertainty to traditional enterprises which rely on imported materials. The Group's operation in China has been inevitably affected in the short term. In 2018, revenue from the Group's European and North American operations accounted for 82.4% of the total revenue of the Group, while that of our operation in China accounted for approximately 17.6%, down by 7.6% as compared with 25.2% in 2017. However, with the introduction of the new policies, the retirement and collection of scraps from the upstream, as well as the demand for copper in the downstream domestic market will remain unchanged. The Group has an extensive network of collection and processing yards across Europe and North America. We started mechanical processing and sorting of scrap motors in the yards in the US and Europe, while our set up in Southeast Asia is intensively under preparation and will be put into operation in 2019 successively. At the same time, the Group will take advantage of the opportunity rising from the consolidation of the local recycling industry to expand our domestic scrap metal business in the PRC. With our strengths and resources, the Group is able to sort out a new model of the global supply chain for non-ferrous scrap with higher economic efficiency, and further consolidate and enhance our strengths in this regard through the transformation.

Upon approval by the Ministry of Environmental Protection of the PRC, the Group has officially begun the recycling of waste lubricants in Yantai, Shandong Province, China since the beginning of 2018. Recycled lubricants are hazardous wastes, the recycling of which requires enterprises to meet relevant requirements and possess relevant qualifications. We have received the Permit for Operation of Hazardous Wastes (《危險廢物經營許可證》) for our production site in Yantai in the second half of 2017. This business has been developing steadily with expanding scales, making our production site in Yantai the largest site for lubricants recycling with advanced technologies in eastern and central China. The Group believes that waste oil recycling industry has a promising prospect in China and will gradually expand the business to other provinces through our qualifications obtained and operational experience accumulated.

二零一八年是中國回收金屬行業重要的一年。包括廢舊電機、電線的第七類固廢的進口在二零一八年底禁止。新政策為傳統依賴進口原料的企業帶來了很大的不確定性。我們在中國的業務難以避免短期內受到一定的影響。2018年，本集團的歐美業務的收入佔比82.4%，中國的業務佔比約17.6%，比2017年的25.2%下降7.6%。但是，新政策出台後，並不能改變的是上游的報廢和廢料產出，以及下游中國市場對銅的需求。集團在歐洲和北美洲均分佈有密集的料場網絡。我們正在利用美國和歐洲料場實驗廢舊電機的機械化處理及分選方案；在東南亞我們的佈局工作也在緊鑼密鼓的進行中並將會在2019年陸續投入運營。同時，我們將藉中國國內再生行業整合的契機伺機拓展國內廢舊金屬業務。我們有能力有條件有資源在變化中梳理出具有最大經濟效率的有色廢料全球供應鏈新模式，並通過變革進一步鞏固並擴大集團在這方面的優勢。

本集團位於中國山東省煙台從事國內廢潤滑油再生回收處理的業務在獲得中國環保部批准之後自二零一八年年初正式投產。回收潤滑油屬於危廢，只有符合要求和有資質企業才能從事經營。煙台生產基地已在二零一七年下半年取得《危險廢物經營許可證》，該業務穩步發展，漸成規模，是華東華中地區最大規模並擁有先進技術的回收潤滑油處理基地。本集團認為廢油再生在國內具有較大發展前景，將依靠取得的資質和運營經驗，在其他省份逐步鋪開。

As for our recycled metal procurement and trading business in Hong Kong, we have increased our sales of high-quality brass and red copper to third parties, and served as the front end for our yards in Europe and North America in exporting to China. Our trading department in Hong Kong will act as a trading hub and an important channel connecting our production sites in South and South East Asia with the PRC sales network going forward.

In 2018, the Group has put lots of efforts on strengthening leadership. I believe that under the leadership of the Group's international executive management team with rich industrial and professional experience, the Group will upgrade and transform, achieve stable growth, and provide returns to shareholders.

2018 ANNUAL RESULTS

The operating revenue for the year ended 31 December 2018 amounted to HK\$20,912.8 million (2017: HK\$18,491.0 million), which increased by approximately 13.1% when compared to 2017.

The annual profit attributable to shareholders of the Company for the year ended 31 December 2018 was HK\$401.2 million (2017: HK\$426.8 million), which decreased by approximately 6.0% when compared to 2017. The basic and diluted earnings per share for 2018 are HK\$0.25, (2017: basic and diluted earnings per share HK\$0.26).

REGIONAL PERFORMANCE

Europe and North America

In 2018, Europe and North America recorded a revenue of HK\$17,553.2 million, representing an increase of 23.1% when compared to last year (2017: segment revenue HK\$14,260.6 million); and a segment profit of HK\$451.9 million, representing a decrease of 1.3% when compared to last year (2017: segment profit HK\$457.8 million). In the second half of the year, the performance of this segment suffered from increased transportation costs and delays in delivery due to one-off impact brought about by the shortage of land transport capacity resulting from the bumper agricultural product harvest in Austria and the Czech Republic, as well as the shortage of shipping capacity caused by the drought in Germany which led to declining water levels.

香港採購回收金屬和貿易業務已經開始增加對第三方銷售高質量的黃銅、紫銅，並作為本集團歐美貨場對中國的出口貿易最前端。香港貿易中心將做為貿易中轉站，為未來東南亞、南亞基地對接中國大陸銷售網絡的重要橋樑。

於二零一八年，本集團付出巨大努力強化領導能力。本人相信，本集團國際化的執行管理團隊，憑藉其豐富行業和專業經驗，將能夠帶領本集團升級轉型，實現穩定增長，為股東帶來回報。

二零一八年年度業績

截至二零一八年十二月三十一日止年度，營業收益為209億1,280萬港元（二零一七年：184億9,100萬港元），相比二零一七年增加約13.1%。

截至二零一八年十二月三十一日止年度，本公司股東應佔年度溢利4億120萬港元（二零一七年：4億2,680萬港元），比二零一七年下降了約6.0%。二零一八年的每股基本及攤薄盈利為0.25港元（二零一七年的每股基本及攤薄盈利為0.26港元）。

區域業績

歐洲及北美洲

於二零一八年，歐洲及北美洲錄得之收益較去年相比錄得23.1%的增長至175億5,320萬港元（二零一七年分部收益：142億6,060萬港元），分部溢利為4億5,190萬港元（二零一七年分部溢利：4億5,780萬港元），比去年下降1.3%。下半年受奧地利和捷克農產品豐收導致的陸路運輸能力短缺、德國天旱水位下降導致航運運輸能力短缺，運輸成本拉高和訂單交付延誤對業績帶來了一次性影響。

Asia

In 2018, the revenue of the Asia region decreased by 22.1% to HK\$3,751.4 million when compared to last year (2017: segment revenue HK\$4,813.6 million), and a segment profit of HK\$275.2 million was recorded, representing a decrease of 7.0% when compared to last year (2017: segment profit HK\$295.9 million). The decline in results of the Asia region was mainly attributable to the gradually contracted import business in the second half of the year.

PROSPECTS

In 2019, after a year of strong growth in the global economy, we expect to see a softer economic growth. In China, the government will adopt various measures to stabilise the macro economy. On the other hand, the difference of Sino-US trade negotiations in principle should have been resolved, thus the trade war has a chance to come to an end.

The Group will continue to implement stringent risk management and hedging policies on our business in this year, enhance the development strategy of organic growth together with prudent mergers and acquisitions, and expand its business scale gradually. On the whole, the Group enjoyed an increasingly sound financial position, maintained business growth, constantly improved its cash flow and lowering its debt ratios to reduce finance costs. The note issued by the Group in 2016 with a principal amount of US\$200.0 million has also been redeemed upon maturity through refinancing and own funds, and a new round of financing was completed at a lower cost than before even when the Federal Reserve raised interest rates. The management remains cautiously optimistic about the long-term prospects of the Group. At the same time, we are well prepared to cope with short-term changes in the market in which we operate.

亞洲

於二零一八年，亞洲地區的收益較去年相比下降22.1%至37億5,140萬港元（二零一七年分部收益：48億1,360萬港元），分部溢利2億7,520萬港元，（二零一七年分部溢利：2億9,590萬港元），比去年下降7.0%。亞洲地區業績倒退，主要由於下半年進口業務日趨收縮。

前景

面向二零一九年，環球經濟總的來講在經歷西方發展國家此一輪強勁增長後，經濟增長出現放緩的概率提高。中國會採用各種手段來穩定宏觀經濟。另外，中美貿易談判原則上的分歧應該已經排除，貿易戰有望終結。

今年對本集團來講，我們將延續對業務實施嚴謹的風險管理和套保政策，強化內在增長及審慎的兼併收購的發展路徑，逐步壯大規模。整體而言，我們的財務狀況漸趨穩健，保持業務增長、現金流持續改善和降低負債比率以減少財務成本。本集團於二零一六年發行的兩億美元票據也已通過再融資和自有資金完成到期贖回，並在美聯儲加息的環境下以比之前更低的成本完成新的融資。管理層對本集團的長遠發展前景維持審慎樂觀。與此同時，本集團亦做好充分準備，以應付業務所在市場短期內出現的轉變。

Revenue

The Group recognised a record-high revenue in the year ended 2018. The revenue was approximately HK\$20,912.8 million in 2018, representing an increase of approximately 13.1% compared to approximately HK\$18,491.0 million in the year of 2017.

The increase in revenue was largely driven by the higher sales quantities in Europe and North America, which offset the decrease in the Asia region. It was also attributable to the continuous recovery of the ferrous and non-ferrous prices after they bottomed out in the fourth quarter of 2016 and reached a four-year new high during the first half of 2018.


LME Aluminum LME鋁

Gross Profit/Margin

Gross profit for the financial year ended 2018 was HK\$1,684.1 million, a decrease of HK\$644.9 million or 27.7% compared to HK\$2,329.0 million recorded in the previous financial year. Gross profit margin for the year decreased from 12.6% to 8.1%.

The gross profit and gross profit margin showed a significant fluctuation from last financial year, which is a result of the adoption of the new HKFRS 15 in 2018 whereby the outbound freight costs have been reclassified from selling and distribution expenses to cost of sales. Should such reclassification have not been made, the gross profit for 2018 would be HK\$2,304.7 million and the gross profit margin would be 11.0% on a like-for-like basis.

The decrease in gross profit on a like-for-like basis was mainly attributable to higher transportation costs in the Europe region due to shortage of railway and shipping transport capacity.

Profit before interest and tax (EBIT)/Margin

EBIT for the year ended 2018 was HK\$845.5 million, a decrease of HK\$78.0 million or 8.4% compared with the previous financial year. EBIT margin also decreased from 5.0% to 4.0%.

Total operating expenses were HK\$1,332.3 million, a decrease of 28.6% over the previous financial year, primarily due to the reclassification of outbound freight cost from distribution and selling expenses to cost of sales. The like-for-like total operating expenses would be HK\$1,952.9 million, an increase of 4.7% over the previous financial year. Total operating expenses as a percentage of revenue on a like-for-like basis also decreased from 10.1% to 9.3%.

Distribution and selling expenses decreased from HK\$562.3 million to HK\$49.0 million (like-for-like: HK\$669.6 million), a decrease of 91.3% compared with the last financial year (like-for-like: increase of 19.1%). As a percentage of revenue, distribution and selling expenses decreased from 3.0% to 0.2% (like-for-like: slightly increased to 3.2% of revenue).

毛利/毛利率

截至二零一八年止財政年度的毛利為16億8,410萬港元，較上一財政年度錄得的23億2,900萬港元減少6億4,490萬港元或27.7%。年內毛利率由12.6%降至8.1%。

毛利及毛利率較上一財政年度出現大幅波動，乃由於二零一八年採納新香港財務報告準則第15號（其中將銷貨運費由分銷及銷售開支重新分類至銷售成本）所致。倘並無進行有關重新分類，二零一八年的毛利將為23億470萬港元，在可比的基礎上毛利率為11.0%。

在可比的基礎上毛利減少主要是由於鐵路及航運運力不足導致歐洲地區運輸成本上升所致。

除利息及稅項前溢利/溢利率

截至二零一八年止年度的除利息及稅項前溢利為8億4,550萬港元，較上一財政年度減少7,800萬港元或8.4%。除利息及稅項前溢利率亦由5.0%降至4.0%。

經營費用總額較上一財政年度減少28.6%至13億3,230萬港元，主要由於將銷貨運費由分銷及銷售開支重新分類至銷售成本所致。可比同比經營費用總額將為19億5,290萬港元，較上一財政年度增加4.7%。經營費用總額佔收益的百分比在可比的基礎上亦由10.1%降至9.3%。

分銷及銷售開支由5億6,230萬港元下跌至4,900萬港元（可比同比：6億6,960萬港元），較上一財政年度下降91.3%（可比同比：增加19.1%）。分銷及銷售開支佔收益的百分比由3.0%減至0.2%（可比同比：佔收益的百分比輕微上升至3.2%）。

Administrative expenses decreased from HK\$1,303.0 million to HK\$1,283.3 million over the last financial year. The decrease was mainly from decrease in legal and professional fees but offset by increase in salaries and benefits. As a percentage of revenue, administrative expenses decreased from 7.1% to 6.2%.

Profit Attributable to Shareholders and Earnings Per Share

Profit attributable to shareholders of the Company for the year ended 31 December 2018 was HK\$401.2 million, having decreased by HK\$25.6 million or 6.0% as compared to the last financial year. Net profit margin also declined from 2.3% to 1.9%, mainly attributable to the decline in the gross profit margin.

Taxation charges reduced from HK\$110.6 million in the last financial year to HK\$70.4 million in the financial year of 2018. The effective tax rate decreased from 20.2% to 15.0%. The lower taxation charges and effective tax rate are resulted from tax optimisation strategies implemented and settlement of tax disputes in the current financial year.

Basic earnings per share for year ended 31 December 2018 were HK\$0.25 as compared to HK\$0.26 in the previous financial year, representing a decrease of 3.8%.

行政開支由上一財政年度的13億300萬港元下降至12億8,330萬港元。下降主要是由於法律及專業費用減少但被薪金及福利的增加所抵銷。行政開支佔收益的百分比由7.1%減少至6.2%。

股東應佔溢利及每股盈利

截至二零一八年十二月三十一日止年度，本公司股東應佔溢利為4億120萬港元，較上一財政年度下降2,560萬港元或6.0%。淨溢利率亦由2.3%下降至1.9%，乃主要由於毛利率的下降。

稅項支出由上一財政年度的1億1,060萬港元減至二零一八財政年度的7,040萬港元。實際稅率由20.2%減至15.0%。稅項支出及實際稅率的下降乃由於在本財政年度實施稅務優化策略及解決稅務爭端所致。

截至二零一八年十二月三十一日止年度的每股基本盈利為0.25港元，而上一財政年度則為0.26港元，下降3.8%。

Analysis of Cash Flow from Operations

The Group's cash generated from operations before changes in working capital for the year ended 31 December 2018 was HK\$847.0 million, a decrease of 11.3% as compared to HK\$954.9 million in the previous financial year. It was mainly attributable to the decrease in operating profits.

Liquidity and Financial Resources

Shareholders' funds as at 31 December 2018 were HK\$5,175.3 million, an increase of 2.0% from HK\$5,073.1 million as at 31 December 2017. Shareholders' funds per share increased by 2.2% from HK\$3.15 to HK\$3.22.

The Group's financial resources remain stable and steady. As at 31 December 2018, the Group had cash, various bank balances and pledged bank deposits amounting to HK\$1,010.7 million, a decrease of 5.7% or HK\$60.7 million as compared to HK\$1,071.4 million as of 31 December 2017. It was mainly for repayment of external borrowings and the needs in the working capital for expansion of business operation.

Nevertheless, the current ratio increased from 1.12 as at 31 December 2017 to 1.62 as at 31 December 2018. Total external borrowings were approximately HK\$3,787.6 million (31 December 2017: approximately HK\$4,155.2 million). Such borrowings were mainly utilised for the purchase of mixed recycle metal and working capital, and denominated in Euro, U.S. Dollar and Renminbi. Approximately HK\$1,757.9 million (31 December 2017: approximately HK\$2,412.7 million) of borrowings are at fixed interest rates.

The gearing ratio of the Group as at 31 December 2018 was 33.3% (31 December 2017: 34.4%) which is calculated based on the total borrowings divided by our total assets.

The Group has successfully obtained a syndicated term loan facility of up to US\$300.0 million during 2018 for a term of two years with a lower financing cost for the refinancing of existing borrowings and working capital needs.

經營業務所得的現金流量分析

截至二零一八年十二月三十一日止年度，本集團營運資金變動前經營業務所得的現金為8億4,700萬港元，較上一財政年度的9億5,490萬港元減少11.3%，主要是由於經營溢利的減少。

流動資金與財務資源

於二零一八年十二月三十一日，股東資金為51億7,530萬港元，較於二零一七年十二月三十一日的50億7,310萬港元上升2.0%。每股股東資金由3.15港元上升2.2%至3.22港元。

本集團的財務資源保持穩健。於二零一八年十二月三十一日，本集團持有的現金、多項銀行結餘及已抵押銀行存款為10億1,070萬港元，較截至二零一七年十二月三十一日的10億7,140萬港元減少5.7%或6,070萬港元。主要用於償還外部借款及業務經營擴張的營運資金需要。

然而，流動比率由二零一七年十二月三十一日的1.12增加至二零一八年十二月三十一日的1.62。外部借款總額為約37億8,760萬港元（二零一七年十二月三十一日：約41億5,520萬港元）。該等借款主要用於購買混合再生金屬和營運資金，並以歐元、美元及人民幣計值。借款約17億5,790萬港元（二零一七年十二月三十一日：約24億1,270萬港元）按固定利率計息。

本集團於二零一八年十二月三十一日的資產負債比率為33.3%（二零一七年十二月三十一日：34.4%）（根據借款總額除以資產總值計算）。

於二零一八年，本集團已成功獲得一筆最高3億美元較低融資成本的銀團定期貸款融資，為期兩年，用於現有借款的再融資及營運資金需求。

Working Capital Change

Inventories as at 31 December 2018 were HK\$2,105.7 million, having decreased from HK\$2,338.5 million as at 31 December 2017. The inventory turnover days for the financial year dropped to 42 days from 46 days as compared with last financial year. The improvement in turnover days was mainly due to continuous improvement in inventory and procurement management.

Provision for inventories as at 31 December 2018 were HK\$38.8 million, as compared to the provisions of HK\$21.2 million as at 31 December 2017.

Net trade and bills receivables as at 31 December 2018 were HK\$1,367.5 million, increased from HK\$1,307.3 million as at 31 December 2017. Debtor turnover days for the financial year dropped from 27 days to 23 days when compared with the last financial year. The higher receivable balance as at 31 December 2018 was mainly due to increase in revenue in the current financial year compared with the last financial year. The Group adopts a tight management on credit exposure.

Treasury Policies

The Group's treasury policies are designed to mitigate the impact of fluctuations in foreign currency exchange rates arising from the Group's global operations. The Group principally uses forward foreign exchange/ futures contracts as appropriate to hedge the foreign exchange risks/ commodity price risks in the ordinary course of business. It is the Group's policy not to enter into derivative transactions for speculative purposes.





Revenue by Regions




按地區劃分的收益



Sales Quantity by Regions




按地區劃分的銷售量








按產品劃分的收益

The Group's performance

After the completion of the acquisition of one of the world's largest mixed metal recyclers with advanced end-of-life vehicles ("ELV") processing technologies in Europe and North America in two years ago, we are integrating our business operations in Asia, Europe and North America, and became one of the leading worldwide mixed metal recyclers with the capabilities to handle and recycle multiple types of materials. Through the geographic diversification, we are in a good position to mitigate the risks of relying on a single market.

The Group sold in aggregate over 5.3 million tonnes of recycled products in 2018. This represents a 3.3% increase when compared to 5.1 million tonnes being sold in 2017. During 2018, the Group continued its usual practices of buying mixed metal scraps and selling its recycled products in accordance with its processing ability. Moreover, the Group made efforts to streamline and improve the inventory cycle so as to mitigate the short-term impact of price volatility on the overall performance of the Group.

Operation Performance

The Group had extended the metal recycling business from its original operation base in Asia to Europe and North America, becoming a truly global operator, ranking among the top few in the world. Management has then reorganised the Group's business segments for the purpose of reporting and analysis, with specific commentaries made on the continents where the operations situated.

Europe

Our Europe segment provides all steps in recycling mixed metal scraps and is equipped with the one-stop shop service for collecting, gathering, sorting and processing. We are among the processing and technology leaders in ferrous and non-ferrous metal recycling worldwide. We own many advanced processing technologies in scrap metal shredding and post-shredding.

本集團的表現

在兩年前完成收購歐洲及北美洲其中一家具備先進報廢汽車(「報廢汽車」)處理技術的全球最大混合金屬再生商後，我們正整合我們於亞洲、歐洲及北美洲的業務營運，且已躋身全球領先可處理及循環再造多類物料的混合金屬再生商之列。透過地域多元化，在減輕依賴單一市場的風險方面，我們處於有利位置。

本集團於二零一八年合共售出超過530萬噸再生產品，與二零一七年售出的510萬噸相比，增加3.3%。於二零一八年，本集團秉承一貫做法，根據自身的處理能力，買入混合再生金屬並出售其再生產品。此外，本集團致力精簡及改善存貨週期，以減低價格波動對本集團整體表現的短期影響。

營運表現

本集團已將金屬再生業務從原來於亞洲的營運基地擴展至歐洲及北美洲，成為真正的全球性營運商並躋身世界前列。因此，管理層亦就呈報及分析重新組織本集團的業務分部，並按照營運所在地的各大洲作出具體評論。

歐洲

我們的歐洲分部提供再生混合再生金屬的所有工序，配備集收集、集中、分類及處理於一體的一站式服務。我們是全球黑色及有色金屬再生的處理及技術領導者之一，我們擁有多項先進的再生金屬破碎和後破碎處理技術。

Europe (continued)

Our scrap metal shredding services, including cleaning, sorting, shearing, shredding, and pressing, constitute a “One-Stop-Shop” process for all customers and cater to any metal supply needs. In post-shredding technologies, we are able to achieve approximately 97% recovery rate for ELV, ranking as a world leader (95% recycling rate is the existing recovery target under the European Union directive).

In 2018, total segment sales tonnage and revenue in Europe increased by approximately 8.2% from 4.1 million tonnes to 4.4 million tonnes and 25.7% from HK\$12,061.6 million to HK\$15,166.5 million, respectively, as compared to the previous financial year.

Gross profit for the year ended 31 December 2018 was HK\$1,647.9 million, a slight increase of HK\$11.3 million or 0.7% compared with the last financial year, but gross profit margin for the year decreased from 13.6% to 10.9%, excluding the effect from the adoption of HKFRS 15. The segment profit decreased by 3.6% from HK\$460.3 million to HK\$443.5 million.

The drop in Europe’s performance is attributable to the higher transportation costs from the shortage of railway and shipping transport capacity, and the difficult market environment and price development in the latter half of 2018.

North America

The North America segment has advanced recycle process know-how in all relevant process steps from collection, sorting, processing to trading of materials. It operates state-of-the-art shredder technology and has extensive post-shredding technologies in place for recovery optimisation.

For the year ended 31 December 2018, the North America total segment sales revenue increased by approximately 8.5% from HK\$2,199.0 million to HK\$2,386.7 million while the total segment sales tonnage remained flat at approximately 0.6 million tonnes (2017: 0.6 million).

歐洲 (續)

我們的再生金屬破碎服務(包括清潔、分類、剪切、破碎和壓制)為所有客戶提供「一站式服務」並滿足任何金屬供應需求。在後破碎技術方面，我們能達到報廢汽車約97%的回收率，位居全球之冠(95%的回收率是歐盟指令的現有回收目標)。

於二零一八年，歐洲的分部總銷售噸位及總收益較上一財政年度分別由410萬噸上升約8.2%至440萬噸及由120億6,160萬港元上升25.7%至151億6,650萬港元。

截至二零一八年十二月三十一日止年度之毛利為16億4,790萬港元，較上一財政年度微幅增加1,130萬港元或0.7%。撇除採納香港財務報告準則第15號的影響，年內毛利率由13.6%減少至10.9%。分部溢利由4億6,030萬港元減少3.6%至4億4,350萬港元。

歐洲表現下降乃由於鐵路及航運運力不足導致運輸成本上升，以及二零一八年下半年市場狀況及價格走勢困難所致。

北美洲

北美洲分部在由收集、分類、處理至物料買賣的所有有關工序中具備先進的再生處理的專業知識，其採用最先進的破碎技術，且具有廣泛的後破碎技術供回收優化。

截至二零一八年十二月三十一日止年度，北美洲分部總銷售收益由21億9,900萬港元增加約8.5%至23億8,670萬港元，而分部總銷售噸位持平於約60萬噸(二零一七年：60萬)。

North America (continued)

The gross profit and gross profit margin decreased by 1.0% from HK\$291.2 million to HK\$288.4 million and from 13.2% to 12.1% in 2018, respectively, before the reclassification of outbound freight costs to cost of sales under the new HKFRS 15. While the overall macroeconomic conditions in the US were supportive for our business, such as the tax reform and strong demand for steel products in the automotive and construction sectors, the sentiment has been falling as a result of the rising trade protectionism.

Segment profit has turned around from a loss of HK\$2.5 million to a profit of HK\$8.4 million as compared to the last financial year due to tight cost control measures taken.

Asia

In Asia, our major production facilities are situated in Yuen Long (Hong Kong), Taizhou (Zhejiang) and Yantai (Shandong).

In the year of 2018, total segment sales tonnage in Asia segment decreased by approximately 31.4% from 0.46 million tonnes to 0.31 million tonnes and revenue decreased by 22.1% from HK\$4,813.6 million to HK\$3,751.4 million as compared to the last financial year.

Gross profit for the year ended 31 December 2018 was HK\$391.2 million, representing a decrease of HK\$62.0 million or 13.7% compared with the last financial year, while gross profit margin for the year was 10.4%, increase from 9.4% in previous year, excluding the impact from the adoption of the new HKFRS 15. The segment profit for Asia decreased by 7.0% from HK\$295.9 million to HK\$275.2 million.

The decline in results of the Asia segment was mainly attributable to the gradually contracted import business in 2018.

北美洲 (續)

於二零一八年根據新香港財務報告準則第15號將銷貨運費重新分類至銷售成本前，毛利及毛利率分別由2億9,120萬港元減少1.0%至2億8,840萬港元及由13.2%減少至12.1%。儘管美國整體宏觀經濟狀況對我們的業務較為有利，例如稅制改革以及汽車及建築行業對鋼鐵產品的強勁需求，但由於貿易保護主義抬頭，情緒一直下降。

由於採取嚴格的成本控制措施，分部溢利較上一財政年度虧損250萬港元扭虧為盈至溢利840萬港元。

亞洲

於亞洲，我們的主要生產設施位於香港元朗、浙江台州及山東煙台。

於二零一八年，亞洲分部的分部總銷售噸位較上一財政年度由46萬噸減少約31.4%至31萬噸及收益由48億1,360萬港元減少22.1%至37億5,140萬港元。

截至二零一八年十二月三十一日止年度之毛利為3億9,120萬港元，較上一財政年度減少6,200萬港元或13.7%，而年內毛利率由去年的9.4%上升至10.4%（撇除採納新香港財務報告準則第15號的影響）。亞洲之分部溢利由2億9,590萬港元減少7.0%至2億7,520萬港元。

亞洲分部表現下滑乃主要由於二零一八年進口業務逐步收縮所致。

As at 31 December 2018, the Group had pledged certain plants and buildings, land use rights, inventories, trade receivables and bank deposits with an aggregate carrying value of approximately HK\$4,542.4 million (31 December 2017: HK\$4,344.6 million) to secure borrowings.

As at 31 December 2018, the Group had capital commitments in respect of acquisition of property, plant and equipment, additions in construction in progress and set-up of a joint venture which are contracted for but not provided for in the consolidated financial statements and amounted to HK\$116.6 million (31 December 2017: HK\$175.3 million).

As at the date of this report, save as disclosed below, the Board is not aware of any material contingent liabilities.

The Group has contingent liabilities of approximately HK\$27.4 million (31 December 2017: HK\$42.5 million) which consist of non-financial guarantee in favour of investee entities.

A writ of summons was issued by Delco Participation B.V. (“Delco”), as plaintiff, on 21 December 2015 in the High Court of Hong Kong (High Court Action No. 3040 of 2015, “HCA 3040/2015”), followed by an amended writ on 5 December 2016, against the Company and Mr. Fang Ankong (“Mr. Fang”) as defendants for a sum of HK\$57.8 million together with interest and costs. The claim relates to an alleged non-payment of a portion of the loans advanced by Delco Asia Company Limited (“Delco Asia”) to subsidiaries of the Company in accordance with the terms of a shareholders loan assignment dated 24 June 2010 between, amongst others, Delco Asia and the Company. The case is still in progress.

Each of Mr. Fang, a former director of the Company, and HWH Holdings Limited (“HWH”), undertook to the Company to indemnify and hold harmless on demand (on an after-tax basis) the Company against all losses arising out of, inter alia, HCA 3040/2015 in accordance with the terms of a letter of indemnity signed by Mr. Fang and HWH in favour of the Company on 17 December 2015. Further, HWH has also agreed that a sum including the amount of HK\$57.8 million be held in escrow as security for any liability of the Company in respect of, inter alia, HCA 3040/2015. As such, the Board does not consider HCA 3040/2015 to be a claim of material importance.

Delco Participation B.V. (「Delco」) 作為原告於二零一五年十二月二十一日以本公司及方安空先生 (「方先生」) 作為被告索償利息及成本5,780萬港元向香港高等法院提交訴狀 (高院案例二零一五年第3040號, 「HCA 3040/2015」), 並於二零一六年十二月五日提交修訂傳票。該索償聲稱未根據 (其中包括) Delco Asia Company Limited (「Delco Asia」) 與本公司於二零一零年六月二十四日訂立的股東貸款轉讓條款支付Delco Asia向本公司子公司墊付貸款的部分款項。案件仍在進行中。

方先生 (本公司前任董事) 及HWH Holdings Limited (「HWH」) 各自向本公司承諾, 根據方先生與HWH以本公司為受益人於二零一五年十二月十七日簽署的彌償函件的條款, 彌償本公司因 (其中包括) HCA 3040/2015產生的所有損失及使本公司免受損失 (按除稅後基準)。此外, HWH亦同意, 把一筆總額為5,780萬港元的款項存放於託管賬戶以作為對本公司有關 (其中包括) HCA 3040/2015的任何責任的擔保。因此, 董事會認為HCA 3040/2015並非重大申索。

A writ of summons was issued by Delco as plaintiff on 10 November 2016 in the High Court of Hong Kong (High Court Action No. 2939 of 2016, "HCA 2939/2016") against the Company as the 1st defendant, Chiho-Tiande (HK) Limited ("CTHK"), a wholly-owned subsidiary of the Company, as the 2nd defendant, HWH as the 3rd defendant, and Mr. Fang as the 4th defendant. So far as the Company and its subsidiaries are concerned, Delco claimed against the Company for damages for an alleged breach of a letter of undertaking dated 3 March 2015 in relation to a convertible bond issued by the Company and subscribed for by Delco on 1 March 2012. Delco further claimed against CTHK for a sum of US\$1.0 million, allegedly advanced by Delco Asia to CTHK on or around 16 April 2009. Delco further claims interests, costs and further or other relief. The Company and CTHK filed their defence on 24 March 2017 and the plaintiff filed its reply to the Company and CTHK's defence on 20 June 2017. The case is still in progress.

Whilst the Board does not consider HCA 2939/2016 to be a claim of material importance for the reason set out above, details of HCA 2939/2016 are disclosed herein for the sake of completeness.

董事會因上文所載理由認為HCA 2939/2016並非重大申索，於本報告中披露HCA 2939/2016的詳情僅為保持完整。

RISK MANAGEMENT

The Group in its ordinary course of business is exposed to market risks such as commodities price risk, foreign currencies risk, interest rate risk, credit risk and liquidity risk. The Group's risk management strategy aims minimising the adverse effects of these risks on its financial performance.

On 7 March 2018, the Group adopted a commodity price risk hedging policy the Board believes is suitable for the current operating conditions. The commodity price risk hedging policy is posted on the Company's website, www.chihogroup.com.

As part of its foreign currency hedging strategy, the Board closely monitors the Group's foreign currency borrowings in view of the volatile exchange rate of Euro, Renminbi and other relevant currencies to U.S. Dollar and considers various measures to minimise foreign currency risk.

Regarding credit risk, the Group continues following the best practices of cash collection for sales of most recycled products in order to minimise the carrying amounts of the financial assets in the Group's financial statements. In addition, the Group continues monitoring closely its trade debtors to minimise potential impairment losses.

Regarding liquidity risk, the Group continues maintaining a balance between the continuity of funding and flexibility through the use of bank borrowings.

風險管理

在日常業務過程中，本集團面對的市場風險包括商品價格風險、外幣風險、利率風險、信貸風險及流動資金風險等。本集團的風險管理策略旨在減低該等風險對本集團財務表現的不利影響。

於二零一八年三月七日，本集團採納商品價格風險對沖政策，董事會認為其較適合現行營運狀況。有關商品價格風險對沖政策的詳情已發佈於本公司網站www.chihogroup.com。

作為本集團的外幣對沖策略的一部分，鑒於歐元、人民幣及其他有關貨幣兌美元匯率波動，因此董事會將密切監察本集團的外幣借款，並考慮多項措施以減少外幣風險。

信貸風險方面，本集團就其大多數再生產品銷售繼續奉行貨到付現的最佳慣例，旨在減低本集團財務報表中的金融資產賬面值。此外，本集團繼續密切監察貿易應收賬情況，以減低潛在減值虧損。

至於流動資金風險方面，本集團繼續透過利用銀行借款，在持續獲取資金與保持靈活程度之間維持平衡。

EMPLOYEES AND REMUNERATION POLICY

As at 31 December 2018, the Group had a workforce of 3,338 employees. In addition, we engaged approximately 805 separation and selection workers through local recognised contractors. We have not experienced any strikes, work stoppages or significant labor disputes which have affected our operations in the past. We have not experienced any significant difficulties in recruiting and retaining qualified staff. We continue to maintain good relationships with our employees.

The Group's total staff costs for the year was approximately HK\$1,272.8 million. The remuneration package of staff consists of basic salary, mandatory provident fund, insurances and other benefits as considered appropriate. Remuneration of the employees of the Group is determined by reference to the market standard, individual performance and their respective contribution to the Group.

The emoluments of the Directors are subject to the recommendations of the remuneration committee of the Company and the Board's approval. Other emoluments including discretionary bonuses, are determined by the Board with reference to the Directors' duties, abilities, reputation and performance.

INVESTOR RELATIONS AND COMMUNICATIONS WITH SHAREHOLDERS

The Group considers that investor relations are important to a listed company. The Board believes that maintaining a good relationship with investors and keeping them up-to-date on the latest corporate communications and business development in a timely fashion would enhance transparency and strengthen corporate governance of the Group.

Going forward, the Company will continue to make effort to keep our investors abreast of the corporate and business developments, and to introduce the Group's strengths and strategies in order to gain support and recognition from them and also the market in general.

董事酬金由本公司薪酬委員會推薦建議及須經董事會批准。其他酬金（包括酌情花紅）由董事會參考董事的職務、能力、名聲及表現釐定。

投資者關係及與股東的溝通

本集團認為，投資者關係對上市公司十分重要。董事會相信，與投資者建立良好的關係，並適時為投資者更新企業傳訊及業務發展，將能提高本集團的透明度及加強企業管治。

展望將來，本公司將繼續努力，讓我們的投資者了解企業及業務發展情況，並向投資者講解本集團的實力及策略，藉以贏取投資者及整體市場的支持及認同。

EXECUTIVE DIRECTORS 執行董事

Mr. Tu Jianhua (“Mr. Tu”), aged 55, is an executive Director of the Company. He was appointed as an executive Director on 29 April 2015. Mr. Tu is a member of the executive committee and the strategy and investment committee of the Company and he is also the director of certain subsidiaries of the Group. Mr. Tu was appointed as the chief executive officer of the Company during the period from 16 February 2016 to 31 March 2016. He has been the chairman of USUM Investment Group Limited since April 2014. He has been the director of Loncin Group Co., Ltd. (隆鑫集團有限公司) since January 1996 and the director of Loncin Holdings Co., Ltd (隆鑫控股有限公司) since January 2003. USUM Investment Group Limited, Loncin Group Co., Ltd. (隆鑫集團有限公司) and Loncin Holdings Co., Ltd. (隆鑫控股有限公司) are controlling shareholders of the Company.

He served as the chairman of the board of Loncin Holdings Co., Ltd. (隆鑫控股有限公司) in the period from January 2003 to July 2010 and from February 2013 to December 2013, the executive director of Loncin Group Co., Ltd. (隆鑫集團有限公司) from January 1996 to January 1997, and the chairman of the board of Loncin Group Co., Ltd. (隆鑫集團有限公司) from January 1997 to December 2013. He served as the general manager of Chongqing Loncin Gasoline Engine Company (SinoAmerican Joint Venture) (中美合資重慶隆鑫汽油機公司), a company that used to be controlled by Mr. Tu during its existence, from 1995 to 1996, and served as the chairman of Chongqing Loncin Transportation and Machinery Factory (重慶隆鑫交通機械廠), a company that used to be controlled by Mr. Tu during its existence, from 1993 to 1995. He served as the chairman of Chongqing City Jiulongpo District Loncin Metal Factory (重慶市九龍坡區隆鑫金屬廠), a company that used to be controlled by Mr. Tu during its existence, from 1991 to 1993 and the factory director of Chongqing Cinhua Metals Factory (重慶鑫華金屬製品廠), from 1983 to 1990.

Mr. Tu graduated from the Economic Management (經濟管理專業) of the Open College in Chongqing City Municipal Party School (重慶市委黨校函授學院) in December 1998. The Company acts as an investment holding company. The principal activities of its principal subsidiaries are set out in Note 44 to the consolidated financial statements.

The results of such measures were reviewed and feedbacks were provided to the customers. The main duties include conducting customer satisfaction survey by sending out questionnaires to have their feedbacks, opinions, suggestions, complaints or praises to ensure the service quality and to make improvement.

Pursuant to the Subscriptions Agreement, Mr. Tu and USUM Investment Group Hong Kong Limited 渝商投資集團(香港)有限公司("USUMHK") shall also provide a personal guarantee and a corporate guarantee, respectively, in favour of the Subscriber to secure, among others, the due and punctual observance and performance by the Company under the Subscriptions Agreement and other documents.

For the purposes of this clause, "control" of each person means (whether by way of ownership of shares, proxy, contract, agency or otherwise): (a) having the power to cast, or control the casting of 40% of the votes that might be cast at a general meeting of such person; or (b) having the power to appoint a majority of the board of directors or remove any director of such person; or (c) having the power or ability to influence the management and financial policies of such person. If any event of default occurs, the Subscriber may require the Notes to be repaid immediately. As at the date of this report, USUMHK owns 62.85% of the total issued share capital of the Company and Mr. Tu indirectly owns 45.956% of the total issued share capital of USUMHK.

A supplemental agreement dated 29 June 2018 (the "Supplemental Agreement") was entered into between the Company and the Subscriber and pursuant to which the Company may early redeem the Notes subject to the terms and conditions of the Supplemental Agreement.

Three redemptions were conducted on 29 June 2018, 3 July 2018 and 20 December 2018 according to the Subscriptions Agreement and the Supplemental Agreement and Notes in the principal amount of US\$80,800,000, of US\$78,000,000 and US\$41,200,000, being US\$200,000,000 in total, were redeemed respectively.

As at 31 December 2018, all principal amount of the Notes and related fees and expenses had been fully redeemed by the Company.

SALES FRAMEWORK AGREEMENT

As disclosed in the announcement of the Company dated 11 January 2017, a number of connected transactions have been entered into and will continue to be carried out between the Company, members of the Group and Loncin International Limited ("Loncin International") according to the sales framework agreement (the "Sales Framework Agreement") entered into between the Company and Loncin International on 11 January 2017. Pursuant to the Sales Framework Agreement, Loncin International shall purchase and the Company shall supply, or shall procure relevant member(s) of the Group to supply, certain products to Loncin International for a term commencing from 11 January 2017 and ending on 31 December 2019.

The annual caps in respect of the transactions contemplated under the Sales Framework Agreement for each of the financial years ended/ending 31 December 2017, 2018 and 2019 are US\$150.0 million, US\$250.0 million and US\$350.0 million respectively. The total amount of the transactions for the year ended 31 December 2018 was US\$58.3 million.

Mr. Tu, a Director and controlling shareholder of the Company, holds 98% equity interests in Loncin Group Co., Limited, which in turn holds 98% equity interests in Loncin Holdings Co., Limited ("Loncin Holdings"). Loncin International is wholly-owned by Loncin Holdings. Therefore, Loncin International is a connected person of the Company under the Listing Rules by virtue of being an associate of Mr. Tu.

Accordingly, the Sales Framework Agreement constitutes a continuing connected transaction for the Company and was subject to the reporting, announcement and independent shareholders' approval requirements under Chapter 14A of the Listing Rules. On 17 February 2017, an extraordinary general meeting of the Company was convened and the Sales Framework Agreement was duly approved.

On 16 October 2018 (after trading hours), Taizhou Chiho-Tiande Metals Company Limited* (台州齊合天地金屬有限公司), an indirectly wholly-owned subsidiary of the Company, entered into a framework sale and purchase agreement (the "Framework Sale and Purchase Agreement") with Chongqing USUM Recycling Resources Developments Co., Ltd.* (重慶渝商再生資源開發有限公司) ("USUM Recycling") for a term of six (6) months commencing from 16 October 2018 regarding the supply of scrap copper/brass to USUM Recycling for a total consideration of up to RMB100.0 million (equivalent to approximately HK\$113.4 million). The total amount of the transactions for the year ended 31 December 2018 was RMB97.5 million.

USUM Investment Group Hong Kong Limited ("USUMHK"), being a controlling shareholder of the Company, is a direct wholly-owned subsidiary of USUM Investment Group Limited* (渝商投資集團股份有限公司) ("USUM Investment") which directly holds 100% interest in USUM Recycling. Accordingly, USUM Recycling is a connected person of the Company as defined in the Listing Rules and the transactions contemplated under the Framework Sale and Purchase Agreement constitute continuing connected transactions for the Company under Chapter 14A of the Listing Rules.

Details were disclosed in the announcement of the Company dated 16 October 2018.

LOAN AGREEMENT

On 20 October 2018, Taizhou Chiho-Tiande Foundry Company Limited* (台州齊合天地鑄造有限公司), an indirectly wholly-owned subsidiary of the Company, as lender, entered into a loan agreement (the "Loan Agreement") with USUM Investment as borrower in respect of the loan in the amount of RMB32.0 million (equivalent to approximately HK\$36.2 million) for a term of ninety (90) days.

USUM Investment is holding 100% of USUMHK which is a controlling shareholder of the Company. Accordingly, USUM Investment is a connected person of the Company as defined in the Listing Rules and the transaction contemplated under the Loan Agreement constitutes a connected transaction for the Company pursuant to Chapter 14A of the Listing Rules.

The Post-IPO Share Option Scheme was approved by written resolutions of the shareholders of the Company and as approved by the listing committee of the Stock Exchange is valid and effective for a period of 10 years commencing on 23 June 2010. It is a share incentive scheme established to recognise and acknowledge the contributions that the eligible participants have or may have made to the Group. Pursuant to the Post-IPO Share Option Scheme, the Board may, as its discretion, offer to grant an option to any director, employee, advisor, consultant, distributor, contractor, supplier, customer, agent, business partner, joint venture business partner, promoter, service provider of any member of the Group.

When the Post-IPO Share Option Scheme was adopted on 23 June 2010, the original scheme mandate limit in respect of which share options could be granted under the Post-IPO Share Option Scheme was 100,000,000 Shares and it was refreshed during the 2013 extraordinary general meeting of the Company.

Pursuant to the terms of the Post-IPO Share Option Scheme and in compliance with the provisions in Chapter 17 of the Listing Rules, the maximum number of Shares which may be issued upon exercise of all share options to be granted under the Post-IPO Share Option Scheme and all other share option schemes of the Company shall not exceed 161,973,829 Shares, being 10% of the Shares in issue as at 17 February 2017, being the date of the 2017 extraordinary general meeting ("2017 EGM"), when the scheme mandate limit was last refreshed.

The total number of Shares issued and which may fall to be issued upon exercise of the options granted under the Post-IPO Share Option Scheme to eligible participants in any 12 months period up to the date of grant shall not exceed 1% of the Shares in issue as at the date of grant, any further grant of options in excess of this 1% limit shall be subject to the approval of Shareholders in a general meeting.

A share option may be exercised in accordance with the terms of the Post-IPO Share Option Scheme at any time during the period to be determined and notified by the Board to the participant at the time of making an offer for the grant of share option.

The total number of securities available for issue under the Post-IPO Share Option Scheme under the refreshed Scheme mandate limit, and all other share option schemes of the Company must not exceed 161,973,829 shares, representing 10.09% of the total number of Shares of the Company as at the date of this report.

No share option has been granted, exercised, cancelled or lapsed from the date of the scheme limit last refreshed to 31 December 2018 under the Share Option Scheme.

Save as disclosed above, no share options have been granted under the Post-IPO Share Option Scheme since the refreshment of the Scheme Mandate Limit on 17 February 2017. An offer of the grant of a share option shall be accepted by the eligible participants within a period of 28 days from the date of offer of grant of share option. INTRODUCTION

The Company recognises the importance of maintaining a high standard of corporate governance. The Company believes that an effective corporate governance practice is fundamental to enhancing shareholder value and safeguarding the interests of Shareholders and other stakeholders. The Board sets appropriate policies and implements corporate government practices appropriate to the conduct and growth of the Group's business. The code provisions set out in the Corporate Governance Code contained in Appendix 14 to the Listing Rules (the "CG Code") have been adopted to shape the Company's corporate governance structure. This corporate governance report describes how the principles of the CG Code have been applied during the year ended 31 December 2018 under different aspects.

COMPLIANCE WITH THE CORPORATE GOVERNANCE CODE

The Company recognises the importance of corporate transparency and accountability and is committed to achieving a high standard of corporate governance. Throughout the year ended 31 December 2018, the Company has complied with all the applicable code provisions of the CG code and Corporate Governance Report, contained in Appendix 14 to the Listing Rules, with exceptions as explained below:

Pursuant to code provision A.2.1 of the CG Code, the roles of chairman and chief executive should be separate and should not be performed by the same individual. Mr. Qin Yongming currently holds the offices of chairman of the Board ("Chairman") and chief executive officer ("CEO") of the Company. The Board believes that vesting the roles of both Chairman and CEO in the same person provides the Company with strong and consistent leadership and allows for effective and efficient planning and implementation of business decisions and strategies. Accordingly, the Directors consider that the deviation from provision A.2.1 of the Code is appropriate in such circumstance.

The Company will, from time to time, review the effectiveness of the Group's corporate governance structure and consider whether any changes, including the separation of the roles of Chairman and CEO, are necessary.

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

In accordance with code provision A.2.1 of the CG Code, Mr. Qin Yongming, has taken up the role of Chairman and Chief Executive Officer simultaneously.

Mr. Qin Yongming is responsible for providing leadership of the Board and ensuring that all Directors are properly informed on issues to be discussed at Board meetings. In addition, he is responsible for ensuring that all Directors receive, in a timely manner, adequate, complete and reliable information in relation to the Group's affairs. The Chairman also encourages Directors to actively participate in and to make a full contribution to the Board so that the Board functions effectively and acts in the best interest of the Company.

Mr. Qin Yongming is also responsible for the strategic planning, administration and management of the business of the Group. He is also responsible for the formulation and successful implementation of Group policies and assuming full accountability to the Board for all operations of the Group. Mr. Qin Yongming oversees the Group's compliance and internal control matters and maintains an ongoing dialogue with the Chairman and all Directors to keep them fully informed of all major business developments and issues. He has also been focusing on strategic planning and assessment of mergers and acquisitions opportunities for the Company.

INDEPENDENT NON-EXECUTIVE DIRECTORS

All independent non-executive Directors were appointed for term of three years. None of them hold any other offices in the Company or any its subsidiaries or is interested in any Shares of the Company under their respective letter of appointment. In the Board meetings and Board committee meetings held during the year, constructive views and comments are given by the independent non-executive Directors, who have provided their independent judgment on the issues relating to the strategy, performance, conflict of interest and management process of the Group.



During the year ended 31 December 2018, the Nomination Committee considered the age, education background and working experience of the candidates when selecting the executive Directors.

The Nomination Committee will review the Board Diversity Policy, as appropriate, to ensure its continued effectiveness from time to time.

REMUNERATION COMMITTEE

The Remuneration Committee was established in June 2010 with written terms of reference in compliance with the CG Code as set out in Appendix 14 to the Listing Rules. The written terms of reference of the Remuneration Committee are available on the Stock Exchange's website and the Company's website.

The Remuneration Committee is responsible for making recommendations to the Board on, among other things, the Company's policy and structure for the remuneration of all directors and senior management of the Company, and the remuneration packages for all executive Directors and senior management of the Company.

The remuneration for the executive Directors comprises basic salary, allowance and discretionary bonus.

Salary adjustments are made where the Remuneration Committee takes into account performance, contribution and responsibilities of the individual. Apart from basic salary, executive Directors and employees are eligible to receive a discretionary bonus taking into account factors such as market conditions as well as corporate and individual's performance during the year.

STRATEGY AND INVESTMENT COMMITTEE

In order to cope with the Group's development needs, enhance scientific planning and decision-making, promote the effectiveness of material investment decision-makings and improve the corporate governance structure of the Group, the Company established the Strategy and Investment Committee in December 2015. The written terms of reference of the Strategy and Investment Committee have been subsequently adopted on 2 February 2016 and are available on the Company's website.

The principal functions and responsibilities of the Strategy and Investment Committee are to (i) study on the development strategies and planning; and (ii) advise on the decision-makings on material investments and capital operation of the Company.

The duties of the Strategy and Investment Committee include the following aspects:

- (i) to act as a delegate for the Board generally;
- (ii) to make decisions and pass resolutions, and to exercise all powers of the Board on all matters of the Company in relation to its daily operations and investment activities, including any non-connected transaction if the applicable percentage ratios calculated under Rule 14.07 of the Listing Rules less than 5%; and
- (iii) to make recommendations to the Board concerning matters of corporate significance not otherwise dealt by any other committees of the Board, recommendations must be submitted to the Board for approval in respect of all transactions if the applicable percentage ratios calculated under Rule 14.07 of the Listing Rules equal to or are more than 5%.

PRICING COMMITTEE

The Pricing Committee currently comprising Mr. Qin Yongming, Mr. Wong Wun Lam, Mr. William Thomas Bird and Mr. Udo Langhans and chaired by Mr. Qin Yongming with appropriate qualifications and experiences has been established and delegated with the operations of the Group's policy regarding dealings in metal futures contracts (the "Policy"). It determines the range of metal futures contracts that the Group may enter into during the month. On a daily basis, the Pricing Committee reviews the open positions of the Group and determines (i) the offer and sell price of our physical stock and our hedging requirements; (ii) the quantity and the price of the metal futures contracts that the Group is going to buy or sell; (iii) enhance the risk management of commodity price fluctuations and to ensure an effective risk monitoring system.

The Board receives a report from the Pricing Committee on the Group's metal futures activities carried out. Should the Pricing Committee determine that any positions are to be taken, it must inform the Board and provide supporting reasons in its report. In addition, the Company's finance department assesses and reports to the Board on the open positions of the Group based on the Group's cash position.

In the event the report from the Company's finance department demonstrates that the Group is not in strict compliance with the hedging limit and the daily limit, the Group will put in place and implement a plan to decrease the open positions of the Group within a reasonable time in order to comply with the limits.

Following a review of the current business operations, internal controls, risk management and policies and practices regarding dealings in metal futures contracts of the Group, on 7 March 2018, the Board adopted a commodity price risk hedging policy which the Board believes is more suitable for the current operating conditions of the Group.

Throughout the year ended 31 December 2018, the Pricing Committee has reviewed the Group's monthly physical stock price and commodities transactions. The Pricing Committee held review meetings with the Board of Directors in 2018 to review and discuss the Pricing Committee Report. RISK MANAGEMENT AND INTERNAL CONTROL

Responsibility of the Board and management

The Board is responsible for overseeing and ensuring the Group has established and maintained an appropriate and effective risk management and internal control systems where management is responsible for the design and implementation of the risk management and internal control systems.

The Company leverages on the expertise offered by internal and external professionals to develop its internal control system, which includes a well-established corporate structure and an organisation with clearly defined lines of responsibility and authority.

The Group's risk management and internal control systems are designed to assist the Group in meeting its strategic objectives. These systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

Risk Management Framework

The Group has established an Enterprise Risk Management ("ERM") framework to assist the Group in managing its risks. The Group's ERM framework includes the following key elements:

- (1) Risk Identification – A Risk Universe fits for the Group's business model has been established. Relevant risks faced by the Group have been identified and the risks are classified into four types, namely, strategic, operational, financial reporting and compliance Risk;
- (2) Risk Assessment – A Risk Workshop amongst key management members was conducted to assess and priorities the risks of the Group. The risks are assessed in terms of the likelihood of their occurrence and the significance of their impact by the key management of the Group;
- (3) Risk Mitigation – A Risk Owner is assigned to each key risk identified. Each Risk Owner is responsible for the risk assigned. Risk mitigation actions are tailored and established to address the risks; and

風險管理及內部監控

董事會及管理層的責任

董事會負責監督並確保本集團已建立、維持適當有效的風險管理及內部監控系統，而管理層則負責設計並執行風險管理及內部監控系統。

本公司憑藉公司內外的專業人員的專業知識發展其內部監控系統，包括良好的公司架構及職責與權力的明確分立。

本集團的風險管理及內部監控系統旨在協助本集團實現其策略目標。這些系統旨在管理而非消除未能實現業務目標的風險，並且只能對重大錯報或損失提供合理而非絕對的保證。

風險管理框架

本集團建立了企業風險管理（「企業風險管理」）架構來協助本集團管理風險。本集團企業風險管理框架包括以下幾個重要方面：

- (1) 風險辨別—確定了適合本集團商業模式的風險圈。本集團辨別面臨的相關風險並將風險歸為四大類，即戰略風險、營運風險、財務報告風險及合規風險；
- (2) 風險評估—本集團採用了風險工作坊，主要管理成員通過該工作坊評估本集團面臨的風險並將其進行重要性排序。本集團主要管理層在評估風險時根據其發生的可能性及可能產生影響的重要性來評估；
- (3) 風險消除—每個辨別出的主要風險都有一個風險負責人。各風險負責人對其被指定的風險負責。我們針對不同風險個別制定消滅措施以消除該風險；及

- (4) Risk Monitoring and Reporting – Risk Owner is responsible for ensuring the risk mitigation plan is executed and implemented properly by appropriate parties (e.g. with appropriate measures/adequate policies and procedures in place). Internal Audit has a role to evaluate and assess if the risk mitigation plans are designed and operated effectively by management. The development and the status of the ERM program is reported to the Audit Committee on a regularly basis.

The implementation of the Group's ERM framework was assisted by management, the Group's Pricing Committee, Strategy and Investment Committee and Internal Audit Department. These framework and setup enables the Group to ensure any new and emerging risk relevant to the Group's operation is promptly identified and managed.

Internal Audit

The Group's Internal Audit Department is to provide independent assurance to the Board and executive management on the adequacy and effectiveness of risk management and internal controls for the Group. The Group's Internal Audit Department adopts a risk-and-control based audit approach. The annual work plan of the Group's Internal Audit Department covers major activities and processes of the Group's business units whilst audit plan is reviewed and agreed by the Audit Committee. In addition to the agreed schedule of work, the Group's Internal Audit Department conducts other review and investigative work as may be required. All audit reports are communicated to the Audit Committee and key members of executive and senior management. Audit issues are tracked and followed up for proper implementation, with progress reported to the Audit Committee, executive and senior management periodically. The risk management and internal control system of the Group is reviewed and assessed on an on-going basis by the Executive Directors, and will be further reviewed and assessed at least once each year by the Audit Committee and the Board.

Review of Risk Management and Internal Control Effectiveness

Through the Audit Committee, the Board has conducted an annual review of the effectiveness of the Group's risk management and internal control systems for the year ended 31 December 2018, covering the material financial, operational and compliance controls, and considered the Group's risk management and internal control systems effective and adequate.

The Audit Committee has also conducted an annual review of the adequacy of resources, qualifications, experience and training programs of the Group's internal audit staff and accounting and financial reporting staff and considered that the staffing is adequate and the staffs are competent to carry out their roles and responsibilities.


內部審核

本集團內部審核部門就本集團風險管理及內部監控的充足性及有效性向董事會及執行管理層提供獨立保證。本集團內部審核部門採納以風險及控制為本的審核方式。本集團內部審核部門的年度工作計劃涵蓋本集團業務單位的主要活動及程序，而審核計劃則由審核委員會檢討及批准。除經同意的工作安排外，本集團的內部審核部門會按要求從事其他審閱及調查工作。所有審核報告均交予審核委員會及行政及高級管理層的主要成員。為求妥善實行審核事項，有關進展會定期匯報予審核委員會、行政及高級管理層，予以追查及跟進。本集團的風險管理及內部監控系統由執行董事持續檢討及評估，並由審核委員會及董事會至少每年一次進一步檢討與評估。

COMMUNICATION WITH SHAREHOLDERS

The Company has established a shareholders' communication policy (the "Shareholders' Communication Policy") in March 2012 for setting out the policies, communication strategies and practices of the Company for communication with its shareholders. The Shareholders' Communication Policy enables the Shareholders to obtain comprehensive and plain information of the Company, to exercise their powers on an informed basis and to strengthen their communication with the Company.

It is the policy of the Board, in recommending dividends, to allow the Shareholders to participate in the Company’s profits, and at the same time, to ensure the Company to retain adequate reserves for future growth. The Company’s decision to declare or to pay any dividends in the future, and the amount of such dividends will depend upon, among other things, the current and future operations, financial condition, liquidity position and capital requirements of the Group, as well as dividends received from the Company’s subsidiaries and associates, which in turn will depend on the ability of those subsidiaries and associates to pay a dividend. In addition, any final dividends for a financial year will be subject to the approval of the Shareholders. The declaration and payment of dividends by the Company is also subject to any restrictions under the laws of Bermuda, the laws of Hong Kong, the Company’s articles of association, bye-laws and any applicable laws, rules and regulations.

Whilst this Dividend Policy reflects the Board’s current views on the financial and cash-flow position of the Group, the Board will continue to review this Dividend Policy from time to time and the Board may exercise its sole and absolute discretion to update, amend and/or modify this Dividend Policy at any time as it deems fit and necessary. There is no assurance that dividends will be declared or paid in any particular amount for any given period. The Dividend Policy shall in no way constitute a legally binding commitment by the Company that any dividend will be paid in any particular amount and/or in no way obligate the Company to declare a dividend at any time or from time to time.

The Board strives to maintain an on-going dialogue with the Shareholders of the Company. Shareholders are encouraged to participate in general meetings or to appoint proxies to attend and vote at meetings for and on their behalf if they are unable to attend the meetings. The process of the Company's general meetings are monitored and reviewed on a regular basis, and, if necessary, changes will be made to ensure that Shareholders' needs are best served. The Company uses the annual general meeting as one of the principal channels for communicating with the Shareholders. The Company ensures that Shareholders' views are communicated to the Board.

At the annual general meeting, each substantially separate issue has been considered by a separate resolution, including the election of individual Directors. The Chairman of the Board, chairmen of the respective Board committees and the external auditor usually attend annual general meetings to communicate with and answer questions from the Shareholders.

The last annual general meeting of the Company was the 2017 annual general meeting (the "2017 AGM") which was held at 23/F, Infinitus Plaza, 199 Des Voeux Road Central, Hong Kong on Wednesday, 12 June 2018 at 11:00 a.m.

All resolutions put to Shareholders at the 2017 AGM were passed. The Company's Hong Kong branch share registrar were appointed as scrutineers to monitor and count the poll votes cast at that meeting. The results of the voting by poll were published on the websites of the Company and the Stock Exchange.

We will continue to establish communication opportunities in order to enhance investors' understanding of and confidence in the Company.

WHISTLEBLOWING POLICY

To deter wrongdoing and to promote standards of good corporate practices, the Company adopted a whistleblowing policy in December 2012. This policy aims at encouraging and enabling employees of the Group at all levels and others to report violations or suspected violations and to raise serious concerns about possible improprieties in matters of financial reporting or other matters of the Group.

INFORMATION DISCLOSURE

The Company discloses information in compliance with the securities regulations of the Stock Exchange, and publishes periodic reports and announcements to the public in accordance with relevant laws and regulations. Our primary focus is to ensure information disclosure is timely, fair, accurate, truthful and complete, thereby enabling Shareholders, investors as well as the public, to make rational and informed decisions.

The carrying value of goodwill and intangible assets with indefinite useful lives of the Group as at 31 December 2018 was HK\$756.9 million and HK\$188.3 million, respectively. Majority of goodwill and intangible assets with indefinite useful lives arose from the acquisition of Scholz Group in December 2016.

Cash flows beyond the five-year period were extrapolated using an estimated long term growth rate.

1 GENERAL INFORMATION

Chiho Environmental Group Limited (“the Company”) is an investment holding company. The Company and its subsidiaries (together “the Group”) are mainly engaged in the principal business of metal recycling, involving the recycling of mixed metal scrap into copper scrap, steel scrap, aluminium scrap, iron scrap and other metal scrap in Asia, Europe and North America. The principal activities of its subsidiaries are set out in Note 44.

The Company is incorporated and registered as an exempted company in the Cayman Islands under the Companies Law of the Cayman Islands with limited liability. The address of its registered office is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1-1111, Cayman Islands.

The Company’s ultimate holding company is Loncin Group Co., Ltd. (“Loncin Group”), a limited liability company incorporated in the People’s Republic of China (the “PRC”), and the Company’s immediate holding company is USUM Investment Group Hong Kong Limited (“USUMHK”), a company incorporated in Hong Kong with limited liability. Loncin Group is 98% owned by Mr. Tu Jianhua (“Mr. Tu”), an executive director of the Company.

The Company has its primary listing on The Stock Exchange of Hong Kong Limited.

These financial statements are presented in Hong Kong Dollar (“HK\$”), unless otherwise stated.

1 一般資料

齊合環保集團有限公司（「本公司」）為投資控股公司。本公司及其子公司（統稱「本集團」）主要於亞洲、歐洲及北美洲從事金屬再生業務，涉及將混合再生金屬回收分成廢銅、廢鋼、廢鋁、廢鐵及其他再生金屬。其子公司的主要業務載於附註44。

本公司之最終控股公司為隆鑫集團有限公司（「隆鑫集團」），一間於中華人民共和國（「中國」）註冊成立之有限責任公司。本公司的直接控股公司為渝商投資集團（香港）有限公司（「渝商香港」），一間於香港註冊成立之有限公司。隆鑫集團之98%的股份由本公司執行董事涂建華先生（「涂先生」）擁有。

本公司以香港聯合交易所有限公司為第一上市地。

除另有所指外，此等財務報表以港元（「港元」）呈列。

The principal accounting policies applied in the preparation of these consolidated financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

The consolidated financial statements of the Company have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards (“HKFRS”) and the applicable disclosure requirements of the Rules Governing the Listing of Securities on the Stock Exchange and the applicable disclosure requirements of the Hong Kong Companies Ordinance Cap. 622. The consolidated financial statements have been prepared under the historical cost convention, as modified by the revaluation of financial assets at fair value through other comprehensive income, and financial assets and financial liabilities (including derivative instruments) at fair value through profit or loss, which are carried at fair value.

The preparation of financial statements in conformity with HKFRS requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the Group’s accounting policies.

The consideration transferred for the acquisition of a subsidiary is the fair values of the assets transferred, the liabilities incurred to the former owners of the acquiree and the equity interests issued by the Group. The consideration transferred includes the fair value of any asset or liability resulting from a contingent consideration arrangement. Identifiable assets acquired and liabilities and contingent liabilities assumed in a business combination are measured initially at their fair values at the acquisition date.

Intra-group transactions, balances and unrealised gains on transactions between group companies are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the transferred asset. When necessary, amounts reported by subsidiaries have been adjusted to conform with the Group's accounting policies.

Impairment testing of the investments in subsidiaries is required upon receiving a dividend from these investments if the dividend exceeds the total comprehensive income of the subsidiary in the period the dividend is declared or if the carrying amount of the investment in the separate financial statements exceeds the carrying amount in the consolidated financial statements of the investee's net assets including goodwill.

An associate is an entity over which the Group has significant influence but not control, generally accompanying a shareholding of between 20% and 50% of the voting rights. Investments in associates are accounted for using the equity method of accounting. Under the equity method, the investment is initially recognised at cost, and the carrying amount is increased or decreased to recognise the investor's share of the profit or loss of the investee after the date of acquisition. The Group's investments in associates include goodwill identified on acquisition. Upon the acquisition of the ownership interest in an associate, any difference between the cost of the associate and the Group's share of the net fair value of the associate's identifiable assets and liabilities is accounted for as goodwill.

If the ownership interest in an associate is reduced but significant influence is retained, only a proportionate share of the amounts previously recognised in other comprehensive income is reclassified to profit or loss where appropriate.

The Group's share of post-acquisition profit or loss is recognised in the consolidated statement of profit or loss, and its share of post-acquisition movements in other comprehensive income is recognised in other comprehensive income with a corresponding adjustment to the carrying amount of the investment. When the Group's share of losses in an associate equals or exceeds its interest in the associate, including any other unsecured receivables, the Group does not recognise further losses, unless it has incurred legal or constructive obligations or made payments on behalf of the associate.

聯營公司指本集團對其有重大影響力而無控制權之實體，通常附帶有20%至50%投票權之股權。於聯營公司之投資以權益會計法列賬。根據權益法，投資初步按成本確認，而賬面值會有所增減，以確認投資者於收購日期後應佔被投資方的溢利或虧損。本集團於聯營公司之投資包括就收購事項所識別的商譽。收購聯營公司之擁有權權益後，聯營公司成本與本集團應佔已識別資產及負債之公平淨值之間的任何差異均入賬作為商譽。

倘於聯營公司之所有權權益減少，而重大影響力獲保留，則先前於其他全面收益內確認之金額僅有一定比例部分重新分類至損益（如適用）。

本集團應佔收購後損益於綜合損益表內確認，其應佔收購後其他全面收益變動於其他全面收益內確認，並會對投資賬面值作出相應調整。如本集團應佔聯營公司虧損相等於或超逾其於該聯營公司之權益（包括任何其他無抵押應收款項），則本集團不會確認進一步之虧損，除非本集團已代該聯營公司承擔法定或推定責任或支付款項。

2.3 Associates (continued)

The Group determines at each reporting date whether there is any objective evidence that the investment in the associate is impaired. If this is the case, the Group calculates the amount of impairment as the difference between the recoverable amount of the associate and its carrying value and recognises the amount adjacent to 'share of profit of investments accounted for using equity method' in the consolidated statement of profit or loss.

Profits and losses resulting from upstream and downstream transactions between the Group and its associate are recognised in the Group's financial statements only to the extent of unrelated investor's interests in the associates. Unrealised losses are eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of associates have been changed where necessary to ensure consistency with the policies adopted by the Group.

2.4 Joint arrangements

The Group's joint arrangements are classified as either joint operations or joint ventures depending on the contractual rights and obligations of each investor. The Group has assessed the nature of its joint arrangements and determined them to be joint ventures. Joint ventures are accounted for using the equity method.

2.3 聯營公司 (續)

本集團於各報告日期釐定是否有客觀證據顯示於聯營公司的投資減值。倘出現減值，則本集團按聯營公司的可收回金額與其賬面值的差額計算減值金額，並於綜合損益表內「以權益法入賬之應佔投資溢利」項下確認有關金額。

本集團與其聯營公司間之上游及下游交易所產生的溢利及虧損於本集團財務報表確認，惟僅以非關連投資者於聯營公司之權益為限。未變現虧損會予以抵銷，惟有關交易提供所轉讓資產出現減值之憑證除外。聯營公司之會計政策已按需要作出變更，以確保與本集團所採納者保持一致。

2.4 合營安排

本集團的合營安排分類為合營業務或合營企業，乃視乎各投資方之合約權利及責任作分類。本集團已評估其合營安排之性質，並釐定該等合營安排為合營企業。合營企業使用權益法入賬。

2.4 Joint arrangements (continued)

Under the equity method of accounting, interests in joint ventures are initially recognised at cost and adjusted thereafter to recognise the Group's share of the post-acquisition profits or losses and movements in other comprehensive income. The Group's investments in joint ventures include goodwill identified on acquisition. Upon the acquisition of the ownership interest in a joint venture, any difference between the cost of the joint venture and the Group's share of the net fair value of the joint venture's identifiable assets and liabilities is accounted for as goodwill. When the Group's share of losses in a joint venture equals or exceeds its interests in the joint ventures, including any other unsecured receivables, the Group does not recognise further losses, unless it has incurred obligations or made payments on behalf of the joint ventures.

Unrealised gains on transactions between the Group and its joint ventures are eliminated to the extent of the Group's interest in the joint ventures. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of the joint ventures have been changed where necessary to ensure consistency with the policies adopted by the Group.

The carrying amount of equity-amounted investments is tested for impairment in accordance with the policy described in Note 2.12.

2.5 Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker. The chief operating decision-maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the Executive Committee that makes strategic decisions.

根據權益會計法，於合營企業之權益初步按成本確認，隨後作出調整以確認本集團應佔收購後溢利或虧損及其他全面收益之變動。本集團於合營企業的投資包括收購時確認的商譽。於收購合營企業的所有權權益後，合營企業的成本及本集團應佔合營企業可識別資產及負債公平值淨值間的任何差額入賬列作商譽處理。倘本集團應佔合營企業之虧損等於或超過其於合營企業之權益（包括任何其他無抵押應收款項），本集團不會確認額外虧損，除非本集團產生負債或代表合營企業付款，則作別論。

本集團與其合營企業交易之未變現收益會對銷，以本集團於合營企業之權益為限。除非有證據顯示交易所轉讓資產出現減值，否則未變現虧損亦會對銷。合營企業之會計政策已作出必要更改，確保與本集團所採納之政策一致。

以股權計值之投資之賬面值乃根據附註2.12所述之政策進行減值測試。

2.5 分部呈報

經營分部報告之方式與提供予主要經營決策者之內部報告貫徹一致。已確定作出策略決定之執行委員會為主要經營決策者，負責對經營分部進行資源分配和業績評估。

2.6 Foreign currency translation

(a) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates ('the functional currency'). The consolidated financial statements are presented in HK\$, which is the Company's functional and the Group's presentation currency.

(b) Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions or valuation where items are re-measured. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in the consolidated statement of profit or loss, except when deferred in other comprehensive income as qualifying cash flow hedges and qualifying net investment hedges.

Foreign exchange gains and losses are presented in the consolidated statement of profit or loss within 'other gains, net'.

本集團旗下每個實體之財務報表均以該實體經營所在之主要經濟環境之貨幣(「功能貨幣」)計量。綜合財務報表乃以港元呈列，而港元為本公司之功能貨幣及本集團之呈報貨幣。

(b) 交易及結餘

倘項目進行重新計量時，外幣交易按交易或估值當日之匯率換算為功能貨幣。該等交易結算的匯兌損益，以及外幣資產和負債按年結日匯率換算產生的匯兌損益，均於綜合損益表內確認，惟於其他全面收益作為合資格現金流對沖及合資格淨投資對沖遞延者除外。

匯兌收益及虧損於綜合損益表內「其他收益淨額」下呈列。

(c) Group companies

The results and financial position of all the Group entities (none of which has the currency of a hyper-inflationary economy) that have a functional currency different from the presentation currency are translated into the presentation currency as follows:

- (i) assets and liabilities for each balance sheet presented are translated at the closing rate at the date of that balance sheet;
- (ii) income and expenses for each statement of profit or loss are translated at average exchange rates (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the rate on the dates of the transactions); and
- (iii) all resulting currency translation differences are recognised in other comprehensive income.

On consolidation, exchange differences arising from the translation of any net investment in foreign entities, and of borrowings and other financial instruments designated as hedges of such investments, are recognised in other comprehensive income. When a foreign operation is sold or any borrowings forming part of the net investment are repaid, the associated exchange differences are reclassified to profit or loss, as part of the gain or loss on sale.

(c) 集團公司

本集團旗下所有實體如持有與呈報貨幣不一致的功能貨幣(其中並無任何公司持有通脹嚴重的經濟體系的貨幣),其業績和財務狀況均按以下方法兌換為呈報貨幣:

- (i) 每項資產負債表的資產及負債均按照該資產負債表結算日的收市匯率折算為呈報貨幣;
- (ii) 各項損益表的收入和支出均按照平均匯率折算為呈報貨幣(但若此平均匯率未能合理地反映各交易日之匯率所帶來的累計影響,則按照交易日之匯率折算此等收入和支出);及
- (iii) 所有由此產生的匯兌差異均於其他全面收益確認。

於編製綜合賬目時,換算境外實體任何投資淨額以及指定為該等投資之對沖項目之借貸及其他金融工具產生之匯兌差額於其他全面收益內確認。於出售境外業務或償還組成投資淨額一部分之任何借貸時,相關匯兌差額重新分類至損益,作為出售損益之一部分。

Goodwill and fair value adjustments arising on the acquisition of a foreign entity are treated as assets and liabilities of the foreign entity and translated at the closing rate. Currency translation differences arising are recognised in other comprehensive income.

2.7 Property, plant and equipment

Land and buildings comprise mainly factories and offices. Property, plant and equipment is stated at historical cost less depreciation. Historical cost includes expenditure that is directly attributable to the acquisition of the items. Cost may also include transfers from equity of any gains/losses on qualifying cash flow hedges of foreign currency purchases of property, plant and equipment.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other repairs and maintenance are charged to the consolidated statement of profit or loss during the financial period in which they are incurred.

Depreciation is calculated using the straight-line method to allocate their cost over their estimated useful lives or, in the case of leasehold improvements and certain leased plant and equipment, the shorter lease term as follows:

收購海外實體產生的商譽及公平值調整被視為該海外實體的資產及負債，並按收市匯率換算。所產生的匯兌差額會在其他全面收入中確認。

2.7 物業、廠房及設備

土地及樓宇主要包括廠房及辦公室。物業、廠房及設備按歷史成本減折舊列賬。歷史成本包括收購項目直接應佔的開支。成本亦可以包括從權益轉撥任何外幣購置物業、廠房及設備的合資格現金流量對沖之任何收益／虧損。

後續成本僅會在與項目有關之未來經濟利益很可能會流向本集團，而本集團又能可靠地計量該項目成本之情況下，方會適當地計入資產賬面值或確認為一項獨立資產。已重置部分之賬面值則終止確認。所有其他維修保養費用在產生之財務期間內於綜合損益表中支銷。

折舊乃採用直線法計算，以在其估計可使用年期（租賃裝修及若干租賃廠房及設備則以較短租期）內分配成本。具體如下：

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount (Note 2.12).

Gains and losses on disposals are determined by comparing the proceeds with the carrying amount and are recognised within 'other gains, net' in the consolidated statement of profit or loss.

2.8 Land use rights

Land use rights are located in the PRC and they are classified as operating leases. All land use rights are carried at cost less accumulated amortisation and accumulated impairment losses, if any. Amortisation is provided to write off cost of land use rights on a straight-line basis over the respective lease period.

2.9 Construction in progress

Construction in progress represents buildings, plant and machinery under construction and pending installation and is stated at cost. Cost includes the costs of construction of buildings and the costs of plant and machinery. No provision for depreciation is made on construction-in-progress until such time as the relevant assets are completed and ready for intended use. When the assets concerned are brought into use, the costs are transferred to other property, plant and equipment and depreciated in accordance with the policy as stated in Note 2.7.

資產餘值及可使用年期於各報告期末檢討，並在適當情況下作出調整。

倘一項資產之賬面值高於其估計可收回金額，則該項資產之賬面值會即時調減至其可收回金額 (附註2.12)。

出售之損益乃透過比較所得款項與賬面值而釐定，並於綜合損益表內「其他收益淨額」中確認。

2.8 土地使用權

土地使用權位於中國，分類為經營租賃。所有土地使用權均按成本減累計攤銷及累計減值虧損 (如有) 列賬。攤銷會予以撥備，以於相關租期內按直線基準撇銷土地使用權成本。

2.9 在建工程

在建工程指在建及有待進行安裝的樓宇、廠房及機器，按成本列賬。成本包括樓宇建築成本及廠房和機器的成本。在建工程在相關資產完工及準備就緒可供作擬定用途之時方才提計折舊撥備。倘有關資產投入使用时，成本會轉撥至其他物業、廠房及設備，並根據附註2.7所述的折舊政策。

2.10 Investment properties

Investment properties, principally comprising leasehold land and buildings, is held for long-term rental yields or for capital appreciation or both, and that is not occupied by the Group. Land held under operating leases are accounted for as investment properties when the rest of the definition of an investment property is met. In such cases, the operating leases concerned are accounted for as if they were finance leases. Investment property is initially measured at cost, including related transaction costs and where applicable borrowing costs. Subsequent to initial recognition, investment properties are stated at cost less subsequent accumulated depreciation and any accumulated impairment losses. Depreciation is recognised so as to write off the cost of investment properties over their estimated useful lives and after taking into account of their estimated residual value, using the straight-line method.

An investment property is derecognised upon disposal or when the investment property is permanently withdrawn from use and no future economic benefits are expected from its disposal. Any gain or loss arising on derecognition of the property (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in profit or loss in the period in which the property is derecognised.

投資物業，主要由租賃土地和樓宇組成，持有為獲得長期租金收益或作為資本增值或兩者兼備同時並非由本集團佔用。以經營租賃持有的土地，如符合投資物業的其餘定義，按投資物業記賬。在此等情況下，相關的經營租賃猶如其為融資租賃而記賬。投資物業初始按成本列賬，包括相關的交易成本及（如適用）借款成本。在初始確認後，投資物業按成本減其後累計折舊及任何累計減值虧損列賬。折舊予以確認，以於估計可使用年期使用直線法撇銷投資物業的成本，當中會計及其估計剩餘價值。

投資物業於出售或投資物業永久退出使用及預計其出售將不會產生未來經濟利益時取消確認。取消確認物業產生之任何收益或虧損（計算作出售所得款項淨額與資產賬面值之間的差額）於取消確認物業期間計入損益。

2.11 Intangible assets

(a) Goodwill

Goodwill arises on the acquisition of subsidiaries represents the excess of the consideration transferred, the amount of any non-controlling interest in the acquiree and the acquisition-date fair value of any previous equity interest in the acquiree over the fair value of the identified net assets acquired.

For the purpose of impairment testing, goodwill acquired in a business combination is allocated to each of the cash-generating units (“CGUs”), or groups of CGUs, that is expected to benefit from the synergies of the combination. Each unit or group of units to which the goodwill is allocated represents the lowest level within the entity at which the goodwill is monitored for internal management purposes. Goodwill is monitored at the operating segment level.

Goodwill impairment reviews are undertaken annually or more frequently if events or changes in circumstances indicate a potential impairment. The carrying value of the CGU containing the goodwill is compared to the recoverable amount, which is the higher of value in use and the fair value less costs of disposal. Any impairment is recognised immediately as an expense and is not subsequently reversed.

(a) 商譽

收購子公司所產生的商譽指所轉讓的代價、被收購方任何非控制性權益金額及被收購方任何之前權益於收購日期的公平值，超過所收購可識別淨資產公平值的數額。

為進行減值測試，於業務合併時收購之商譽分配至預期自合併協同效益受惠之各項或各組現金產生單位（「現金產生單位」）。各項或各組獲分配商譽之單位指就內部管理而言實體內監察商譽之最低層面。商譽於營運分部層面監察。

商譽每年檢討減值，或倘出現任何事宜或事態變動，顯示可能出現減值，則每年或更頻密檢討減值虧損。含有商譽的現金產生單位的賬面值會與可收回金額作比較，以可收回金額的使用價值與公平值減出售成本之較高者為準。任何減值即時確認為開支，且其後不會撥回。

(b) Computer software

Computer software acquired are capitalised on the basis of the costs incurred to acquire and bring to use the specific software. These costs are amortised over their estimated useful lives of 5 years.

(c) Brand names, patents and licenses

Separately acquired brand names, patents and licences are shown at historical cost. Brand names, patents and licences acquired in a business combination are recognised at fair value at the acquisition date. Certain brand names, patents and licences have a finite useful life and are carried at cost less accumulated amortisation and impairment losses. Amortisation is calculated using the straight-line method to allocate the cost of certain brand names, patents and licenses over their estimated useful lives of 8 to 20 years. Certain brand names have indefinite useful life and carried at cost less accumulated impairment losses. Impairment assessment is undertaken annually or more frequently if events or changes in circumstances indicate a potential impairment.

(d) Customers' relationship and suppliers' relationship

Customers' relationship and suppliers' relationship acquired in a business combination are recognised at fair value at the acquisition date. The customers' relationship and suppliers' relationship have a finite useful life and are carried at cost less accumulated amortisation and impairment losses. Amortisation is calculated using the straight-line method over the expected life of the customers' relationship and suppliers' relationship of 5 to 20 years.

(b) 電腦軟件

購入電腦軟件按獲得及使用有關軟件所產生之成本為基準予以資本化。該等成本乃按估計可使用年期為五年攤銷。

(c) 品牌名稱、專利及牌照

獨立收購的品牌名稱、專利及牌照按歷史成本列示。於業務合併中收購的品牌名稱、專利及牌照按收購日期的公平值確認。擁有有限可使用年期的若干品牌名稱、專利及牌照按成本減累計攤銷及減值虧損列賬。攤銷採用直線法計算，以於8至20年的估計可使用年期內分配若干品牌名稱、專利及牌照的成本。若干品牌名稱具無限可使用年期，且按成本減累計減值虧損列賬。減值評估須每年進行，倘有事件或改變顯示可能發生減值時，則會更頻密地進行減值評估。

(d) 客戶關係及供應商關係

於業務合併中收購的客戶關係及供應商關係按收購日期的公平值確認。擁有有限可使用年期的客戶關係及供應商關係按成本減累計攤銷及減值虧損列賬。攤銷採用直線法於客戶關係及供應商關係的預期年期5至20年計算。

(e) Non-competition agreement

Non-competition agreement is recognised at fair value at the agreement date. Non-competition agreement has a finite useful life and are carried at cost less accumulated amortisation and impairment loss. Amortisation is calculated using the straight-line method over the agreement term of 2 years.

2.12 Impairment of non-financial assets

Intangible assets that have an indefinite useful life or intangible assets not ready to use are not subject to amortisation and are tested annually for impairment. Assets that are subject to amortisation are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs of disposal and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash flows (cash-generating units). Non-financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at each reporting date.

(e) 競業限制合同

競業限制合同按協議合同日期的公平值確認。擁有有限可使用年期的競業限制合同按成本減累計攤銷及減值虧損列賬。攤銷採用直線法於協議合同的年期2年計算。

2.12 非金融資產減值

無明確可使用年期之無形資產或未達可使用狀態之無形資產毋須攤銷，但須每年進行減值測試。每當有事件或事態變化顯示不可收回賬面金額時，本集團會檢討須作攤銷之資產有否出現減值。減值虧損按資產賬面金額超出其可收回金額之金額確認。可收回金額為資產之公平值減出售成本與使用價值之較高者。於評估減值時，資產按可單獨識別之現金流量之最低水平（現金產生單位）歸類。出現減值之非金融資產（商譽除外）於各報告日期就減值是否有機會撥回進行檢討。

2.13.1 Classification

From 1 January 2018, the Group classifies its financial assets in the following measurement categories:

- those to be measured subsequently at fair value (either through other comprehensive income or through profit or loss), and
- those to be measured at amortised cost.

The classification depends on the Group's business model for managing the financial assets and the contractual terms of the cash flows.

For assets measured at fair value, gains and losses will either be recorded in profit or loss or other comprehensive income. For investments in equity instruments that are not held for trading, this will depend on whether the Group has made an irrevocable election at the time of initial recognition to account for the equity investment at fair value through other comprehensive income.

2.13.1 分類

自二零一八年一月一日起，本集團將其金融資產分類為下列計量類別：

- 其後將按公平值(或透過其他全面收益或透過損益)計量的金融資產；及
- 將按攤銷成本計量的金融資產。

分類視乎本集團用以管理金融資產的業務模式及現金流量的合約條款而定。

至於按公平值計量的資產，收益或虧損將記入損益或其他全面收益。至於非持作買賣的股權工具的投資，將視乎本集團是否已於初步確認時作出不可撤回的選擇，按公平值計入其他全面收益將股本投資入賬。

2.13.1 Classification (continued)

The Group reclassifies debt investments when and only when its business model for managing those assets changes.

2.13.2 Recognition and derecognition

Regular way purchases and sales of financial assets are recognised on trade-date, the date on which the Group commits to purchase or sell the asset. Financial assets are derecognised when the rights to receive cash flows from the financial assets have expired or have been transferred and the Group has transferred substantially all the risks and rewards of ownership.

2.13.3 Measurement

At initial recognition, the Group measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss, transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at FVPL are expensed in profit or loss.

Debt instruments

Subsequent measurement of debt instruments depends on the Group's business model for managing the asset and the cash flow characteristics of the asset.

Derivatives are initially recognised at fair value on the date a derivative contract is entered into and are subsequently re-measured at their fair values. Changes in the fair value of these derivative instruments are recognised immediately in the consolidated statement of profit or loss within 'other gains, net'. The Group does not have any derivative that is designated as a hedging instrument.

2.16 Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined using the weighted average method. The cost of finished goods comprises, raw materials, direct labour, other direct costs and related production overheads. It excludes borrowing costs. Net realisable value is the estimated selling price in the ordinary course of business, less applicable variable selling expenses.

2.17 Trade, bills and other receivables

Trade and bills receivables are amounts due from customers for merchandise sold or services performed in the ordinary course of business. If collection of trade, bills and other receivables is expected in one year or less (or in the normal operating cycle of the business if longer), they are classified as current assets. If not, they are presented as non-current assets.

The Group holds trade, bills and other receivables with the objective to collect the contractual cash flows. Accordingly, trade, bills and other receivables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less allowance for impairment (Note 2.13.4).

Trade, bills and other receivables are written off when there is no reasonable expectation of recovery.

2.16 存貨

存貨按成本與可變現淨值兩者中之較低者列賬。成本值以加權平均法計算。成品之成本包括原材料、直接勞工及其他直接成本及相關生產日常開支，不包括借貸成本。可變現淨值是以日常業務之估計售價減去適用之變動銷售開支後所得之數額。

2.17 貿易、票據及其他應收款項

貿易及票據應收款項為在日常業務過程中就商品銷售或提供服務而應收客戶的款項。倘貿易、票據及其他應收款項的收回預期在一年或以內（或倘較長，則為業務正常經營週期內），其被分類為流動資產，否則分類為非流動資產。

本集團持有貿易、票據及其他應收款項，旨在收取合約現金流量。因此，貿易、票據及其他應收款項以公平值初始確認，其後利用實際利率法按攤銷成本扣除減值撥備計量（附註2.13.4）。

當不存在可收回的合理預期時，貿易、票據及其他應收款項會予以撇銷。

Impairment losses on trade, bills and other receivables are presented as net impairment losses in the consolidated statement of profit or loss. Subsequent recoveries of amounts previously written off are credited against the same line item.

2.18 Cash and cash equivalents

In the consolidated statement of cash flows, cash and cash equivalents include cash in hand, deposits held at call with banks and bank overdrafts. In the consolidated balance sheet, bank overdrafts are shown within cash and cash equivalents in current assets.

2.19 Share capital

Ordinary shares are classified as equity.

Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

2.20 Trade and bills payables

Trade and bills payables are obligations to pay for goods or services that have been acquired in the ordinary course of business from suppliers.

Trade and bills payables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method.

2.21 Borrowings

Borrowings are recognised initially at fair value, net of transaction costs incurred. Borrowings are subsequently carried at amortised cost; any difference between the proceeds (net of transaction costs) and the redemption value is recognised in the consolidated statement of profit or loss over the period of the borrowings using the effective interest method.

普通股被分類為權益。

直接歸屬於發行新股或購股權的新增成本在權益中列為所得款項的減少（扣除稅項）。

貿易及票據應付款項為在日常業務過程中購買商品或服務而應支付供應商的責任。

貿易及票據應付款項以公平值為初始確認，其後利用實際利率法按攤銷成本計量。

2.21 借款

借款按公平值並扣除產生的交易費用為初始確認。借款其後按攤銷成本列賬，所得款項（扣除交易成本）與贖回價值的任何差額利用實際利率法於借款期間內在綜合損益表確認。

Fees paid on the establishment of loan facilities are recognised as transaction costs of the loan to the extent that it is probable that some or all of the facility will be drawn down. In this case, the fee is deferred until the draw-down occurs. To the extent there is no evidence that it is probable that some or all of the facility will be drawn down, the fee is capitalised as a pre-payment for liquidity services and amortised over the period of the facility to which it relates.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the end of the reporting period.

2.22 Borrowing costs

Borrowing costs include interest expense, finance charges in respect of finance lease and exchange differences arising from foreign currency borrowings to the extent that they are regarded as an adjustment to interest costs. The exchange gains and losses that are an adjustment to interest costs include the interest rate differential between borrowing costs that would be incurred if the entity had borrowed funds in its functional currency, and the borrowing costs actually incurred on foreign currency borrowings. Such amounts are estimated based on interest rates on similar borrowings in the entity's functional currency.

2.23 Current and deferred income tax

The tax expense for the period comprises current and deferred tax. Tax is recognised in the consolidated statement of profit or loss, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

除非本集團有無條件權利於報告期末後將負債的結算遞延最少12個月，否則借貸分類為流動負債。

借款成本包括利息開支、融資租賃之融資支出及外幣借款產生之匯兌差異，以其被視為利息成本之調整為限。屬於利息成本之調整之匯兌收益及虧損包括在實體以其功能貨幣借入資金的情況下產生的借款成本與外幣借款實際產生的借款成本之間的利率差異。有關金額根據以實體功能貨幣作出的類似借款的利率估計。

2.23 即期及遞延所得稅

本期間稅項開支包括即期和遞延稅項。稅項在綜合損益表中確認，但與在其他全面收益中或直接在權益中確認的項目有關者則除外。在該情況下，稅項亦分別在其他全面收益或直接在權益中確認。

(a) Current income tax

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the balance sheet date in the countries where the Company's subsidiaries, associates and joint ventures operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation. It establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

(b) Deferred income tax

Deferred income tax is provided in full, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. However, deferred tax liabilities are not recognised if they arise from the initial recognition of goodwill. Deferred income tax is also not accounted for if it arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit or loss. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantially enacted by the end of the reporting period and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

The deferred tax liability in relation to investment property that is measured at fair value is determined assuming the property will be recovered entirely through sale.

遞延所得稅利用負債法，根據資產和負債的稅基與資產和負債在綜合財務報表的賬面值差額而產生的暫時性差異足額撥備。然而，若遞延稅項負債產生自初步確認商譽，則不會確認遞延稅項負債。若遞延所得稅來自在交易（不包括業務合併）中對資產或負債的初始確認，而在交易時不影響會計損益或應課稅損益，亦不作記賬。遞延所得稅採用在報告期末前已頒佈或實質上已頒佈，並在有關的遞延所得稅資產實現或遞延所得稅負債結算時預期將會適用的稅率（及法例）而釐定。

有關按公平值計量的投資物業的遞延稅項負債乃假設該物業將透過出售可完全收回釐定。

(b) Deferred income tax (continued)

Deferred tax assets are recognised only if it is probable that future taxable amounts will be available to utilise those temporary differences and losses.

Deferred tax liabilities and assets are not recognised for temporary differences between the carrying amount and tax bases of investments in foreign operations where the Company is able to control the timing of the reversal of the temporary differences and it is probable that the differences will not reverse in the foreseeable future.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets and liabilities and when the deferred tax balances relate to the same taxation authority. Current tax assets and tax liabilities are offset where the entity has a legally enforceable right to offset and intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

(i) Investment allowances and similar tax incentives

Companies within the Group may be entitled to claim special tax deductions for investments in qualifying assets or in relation to qualifying expenditure. The Group accounts for such allowances as tax credits, which means that the allowance reduces income tax payable and current tax expense. A deferred tax asset is recognised for unclaimed tax credits that are carried forward as deferred tax assets.

(b) 遞延所得稅 (續)

遞延稅項資產僅在未來應課稅金額將可用於動用該等暫時差額及虧損時予以確認。

倘本公司能控制撥回暫時差額的時間及該等差額可能不會於可見將來撥備，則不會就海外業務投資賬面值與稅基之間的暫時差額確認遞延稅項負債及資產。

當有可依法強制執行的權利將即期稅項資產與負債抵銷，而遞延稅項結餘與同一稅務機構相關時，則可將遞延稅項資產與負債抵銷。當實體有可依法強制執行抵銷權利且有意按淨額基準結算或同時變現資產及清償負債時，則即期稅項資產與稅項負債抵銷。

(i) 投資補貼及類似稅收優惠

本集團內公司或有權要求就合資格資產投資或合資格支出獲得特殊稅收減免。本集團將該等補貼作為稅收抵免入賬，意味著該津貼可削減應付所得稅及即期稅項支出。遞延稅項資產就未認領並結轉為遞延稅項資產的稅項抵免進行確認。

2.24 Employee benefits

2.24.1 Short-term obligations

Liabilities for wages and salaries, including non-monetary benefits and accumulating sick leave that are expected to be settled wholly within 12 months after the end of the period in which the employees render the related service are recognised in respect of employees' services up to the end of the reporting period and are measured at the amounts expected to be paid when the liabilities are settled. The liabilities are presented as current employee benefit obligations in the consolidated balance sheet.

2.24.2 Other long-term employee benefit obligations

The liabilities for long service leave and annual leave are not expected to be settled wholly within 12 months after the end of the period in which the employees render the related service. They are therefore measured as the present value of expected future payments to be made in respect of services provided by employees up to the end of the reporting period using the projected unit credit method. Consideration is given to expected future wage and salary levels, experience of employee departures and periods of service. Expected future payments are discounted using market yields at the end of the reporting period of high-quality corporate bonds with terms and currencies that match, as closely as possible, the estimated future cash outflows. Remeasurements as a result of experience adjustments and changes in actuarial assumptions are recognised in profit or loss.

2.24.1 短期責任

僱員直至報告期末之服務獲確認工資及薪金負債(包括預期在僱員提供相關服務期間結束後12個月內悉數結算的非貨幣福利及累計病假)並按結算有關負債之預期金額計量。負債於綜合資產負債表內呈列為即期僱員福利責任。

2.24.2 其他長期僱員福利責任

預期將不會於僱員提供相關服務的期末後12個月內結清的長期服務假期及年假的負債,乃按預期將就直至報告期間結算日僱員所提供服務支付的未來款項現值使用預計單位貸計法計量。當中考慮預期未來工資和薪金水平、員工離職記錄和服務期間。預期未來付款將於報告期間結算日採用到期日及流通率盡可能與估計日後現金流出一致的優質公司債券收益率貼現。因經驗調整及精算假設變動導致的重新計量於損益確認。

2.24.3 Post-employment obligations

The Group operates various post-employment schemes, including for defined benefit plan in Germany and defined contribution pension plans in the PRC and Hong Kong, namely the state-managed retirement benefit schemes and the Mandatory Provident Fund Scheme (“MPF Scheme”) respectively.

(a) *Pension obligations*

A defined contribution plan is a pension plan under which the Group pays fixed contributions into a separate entity. The Group has no legal or constructive obligations to pay further contributions if the fund does not hold sufficient assets to pay all employees the benefits relating to employee service in the current and prior periods. A defined benefit plan is a pension plan that is not a defined contribution plan.

Typically defined benefit plans define an amount of pension benefit that an employee will receive on retirement, usually dependent on one or more factors such as age, years of service and compensation.

2.24.3 僱員結束服務後之責任

本集團運營多項僱員結束服務後之計劃，包括於德國的界定福利計劃及於中國及香港的界定供款退休金計劃，分別為國家管理退休福利計劃及強制性公積金計劃（「強積金計劃」）。

(a) *退休金責任*

界定供款計劃乃本集團向一家獨立實體支付固定界定退休金供款的退休金計劃。若該基金並無持有足夠資產向所有員工就其在當期及以往期間的服務支付福利，本集團無法定亦無推定責任支付進一步供款。界定福利計劃乃一項並非界定供款計劃的退休金計劃。

界定福利計劃一般會釐定僱員在退休時可收取的退休福利金額，通常視乎年齡、服務年資和薪酬補償等一個或多個因素而定。

(a) Pension obligations (continued)

The liability recognised in the consolidated balance sheet in respect of defined benefit pension plans is the present value of the defined benefit obligation at the end of the reporting period less the fair value of plan assets. The defined benefit obligation is calculated annually by independent actuaries using the projected unit credit method. The present value of the defined benefit obligation is determined by discounting the estimated future cash outflows using interest rates of high-quality corporate bonds that are denominated in the currency in which the benefits will be paid, and that have terms to maturity approximating to the terms of the related pension obligation. In countries where there is no deep market in such bonds, the market rates on government bonds are used.

The current service cost of the defined benefit plan, recognised in the consolidated statement of profit or loss in employee benefit expense, except where included in the cost of an asset, reflects the increase in the defined benefit obligation results from employee service in the current year, benefit changes, curtailments and settlements.

(a) 退休金責任 (續)

於綜合資產負債表內就界定受益退休計劃確認的負債為界定受益退休責任於報告期末的現值(扣除計劃資產的公平值)。界定福利責任每年均由獨立精算師以預測單位貸計法計算。界定福利責任的現值乃以使用支付福利的貨幣計值，且到期條款與相關退休責任的條款相約的高質企業債券的利率貼現預計未來現金流出額釐訂。倘於欠缺該等企業債券深廣市場的國家，則採用政府債券的市場率。

界定福利計劃的當期服務成本於綜合損益表確認為僱員福利開支(已包括在資產成本內除外)，反映在現年度因為僱員服務而產生的界定福利債務增加、利益變動、縮減及結算。

(a) Pension obligations (continued)

Past-service costs are recognised immediately in consolidated statement of profit or loss. Changes in the present value of the defined benefit obligation resulting from plan amendments or curtailments are recognised immediately in profit or loss as past service costs.

The net interest cost is calculated by applying the discount rate to the net balance of the defined benefit obligation and the fair value of plan assets. This cost is included in employee benefit expense in the consolidated statement of profit or loss.

Remeasurement arising from experience adjustments and changes in actuarial assumptions are charged or credited to equity in other comprehensive income in the period in which they arise.

For defined contribution plans, the Group pays contributions to publicly or privately administered pension insurance plans on a mandatory, contractual or voluntary basis. The Group has no further payment obligations once the contributions have been paid. The contributions are recognised as employee benefit expense when they are due. Prepaid contributions are recognised as an asset to the extent that a cash refund or a reduction in the future payments is available.

(a) 退休金責任 (續)

過往服務成本即時於綜合損益表確認。因修訂或減省計劃而產生的界定福利責任的現值變動即時於損益確認作過往服務成本。

淨利息成本採用界定福利責任的淨結餘之貼現率及計劃資產的公平值計算。此項成本列入綜合損益表的僱員福利開支內。

因按經驗作出調整及精算假設改變而產生的重新計量於產生期間扣除自或計入其他全面收益。

對於界定供款計劃，本集團以強制性、合同性或自願性方式向公開或私人管理的退休保險計劃供款。本集團作出供款後，即無進一步付款義務。供款到期時，則會確認為僱員福利開支。預付供款按照現金退款或可減少未來付款而確認為資產。

(b) Termination benefits

Termination benefits are payable when employment is terminated by the Group before the normal retirement date, or whenever an employee accepts voluntary redundancy in exchange for these benefits. The Group recognises termination benefits at the earlier of the following dates: (a) when the Group can no longer withdraw the offer of those benefits; and (b) when the entity recognises costs for a restructuring that is within the scope of HKAS 37 and involves the payment of termination benefits. In the case of an offer made to encourage voluntary redundancy, the termination benefits are measured based on the number of employees expected to accept the offer. Benefits falling due more than 12 months after the end of the reporting period are discounted to their present value.

(b) 終止福利

終止福利在本集團於正常退休日期前終止僱用職工，或當職工接受自願遣散以換取此等福利時支付。本集團在以下較早日日期發生時確認終止福利：(a)當本集團不再能夠撤回該等福利要約時；及(b)當主體確認的重組成本屬於香港會計準則第37號的範圍並涉及支付終止福利時。在鼓勵職工自動遣散的要約情況下，終止福利按預期接受要約的職工數目計算。在報告期末後超過12個月支付的福利應貼現為現值。

2.25 Share-based payments

Equity-settled share-based payment transactions

The Group operates a number of equity-settled, share-based compensation plans, under which the entity receives services from employees as consideration for equity instruments (options) of the Group. The fair value of the employee services received in exchange for the grant of the options is recognised as an expense.

At the end of each reporting period, the Group revises its estimates of the number of options that are expected to vest based on the non-marketing performance and service conditions. It recognises the impact of the revision to original estimates, if any, in the consolidated statement of profit or loss, with a corresponding adjustment to equity.

When the options are exercised, the Company issues new shares. The proceeds received net of any directly attributable transaction costs are credited to share capital and share premium.

2.26 Provisions

Provisions for legal claims are recognised when the Group has a present legal or constructive obligation as a result of past events; it is probable that an outflow of resources will be required to settle the obligation; and the amount has been reliably estimated. Provisions are not recognised for future operating losses.

Provisions are measured at the present value of the expenditures expected to be required to settle the obligation using a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the obligation.

以權益結算以股份為基礎的交易
本集團設有多個以權益結算以股份為基礎的酬金計劃，據此實體以權益工具（購股權）為報酬收取僱員的服務。僱員為獲取授予購股權而提供的服務的公平值確認為費用。

在每個報告期末，本集團依據非市場表現及服務條件修訂其對預期歸屬的購股權數目的估計。主體在綜合損益表確認對原估算修訂（如有）的影響，並對權益作出相應調整。

在購股權獲行使時，本公司發行新股。收取的所得款項扣除任何直接歸屬交易成本撥入股本和股份溢價。

2.26 撥備

當本集團因已發生的事件而產生現有的法律或推定義務；很可能需要資源的流出以結算義務；及金額已被可靠估計，則確認法律索償撥備。但不會就未來經營虧損確認撥備。

撥備採用稅前利率按照預期需結算有關義務的支出現值計量，該利率反映當時市場對金錢時間值和有關義務固有風險的評估。

2.27 Revenue recognition

(a) Sales of goods

In adopting HKFRS 15, revenue is recognised when or as the control of the goods is transferred to the customers in accordance with relevant shipping terms. A receivable is recognised when control of the goods is transferred to the customers as this is the point in time that the consideration is unconditional because only the passage of time is required before the payment is due.

(b) Rental income

Rental income from investment property is recognised in the consolidated statement of profit or loss on a straight-line basis over the term of the lease.

(c) Service income

Services income is recognised in the consolidated statement of profit or loss when a service is transferred to the customer and the customer obtains control of that service.

(a) 銷售貨品

於採納香港財務報告準則第15號時，收益乃於貨物的控制權根據相關貨運條款轉移至客戶時確認。應收款項於貨品的控制權轉移至客戶時確認，原因為此時乃代價成為無條件的時間點，於付款到期前僅須隨時間推移即可收取付款。

(b) 租金收入

投資物業租金收入於租期內按直線基準在綜合損益表內確認。

(c) 服務收入

服務收入於提供服務時於綜合損益表內確認。

2.28 Interest income

Interest income from financial assets at FVPL is included in the net fair value gains/(losses) on these assets.

Interest income on financial assets at amortised cost and financial assets at FVOCI (2017: available-for-sale securities, held-to-maturity investments and loans and receivables) calculated using the effective interest method is recognised in the consolidated statement of profit or loss as part of other income.

Interest income is presented as finance income where it is earned from financial assets that are held for cash management purposes. Any other interest income is included in other income.

Interest income is calculated by applying the effective interest rate to the gross carrying amount of a financial asset except for financial assets that subsequently become credit-impaired. For credit-impaired financial assets the effective interest rate is applied to the net carrying amount of the financial asset (after deduction of the loss allowance).

2.29 Dividend income

Dividends are received from financial assets measured at FVPL and at FVOCI (2017: from financial assets at FVPL and available-for-sale financial assets). Dividends are recognised as other income in profit or loss when the right to receive payment is established. This applies even if they are paid out of pre-acquisition profits, unless the dividend clearly represents a recovery of part of the cost of an investment. In this case, the dividend is recognised in other comprehensive income if it relates to an investment measured at FVOCI. However, the investment may need to be tested for impairment as a consequence.

2.28 利息收入

按公平值計入損益之金融資產的利息收入計入該等資產的公平值收益／(虧損)淨值。

有效利息法計算的以攤銷成本入賬之金融資產之利息收入及按公平值計入其他全面收益之金融資產(二零一七年：可供出售證券、持有至到期投資以及貸款及應收賬款)在綜合損益表中確認為部分其他收入。

利息收入呈列為持作現金管理用途的金融資產所賺取的融資收入。任何其他利息收入計入上文其他收入。

利息收入是用實際利率乘以金融資產賬面總額計算得出，惟後續已發生信用減值的金融資產除外。就信用減值的金融資產而言，實際利率適用於金融資產的賬面淨值(經扣除虧損撥備)。

2.29 股息收入

股息自按公平值計入損益及按公平值計入其他全面收益之金融資產收取(二零一七年：自按公平值計入損益之金融資產及可供出售金融資產收取)。當收款權利獲確立時股息確認為其他收益。即使其乃使用收購前溢利支付，本條仍然適用，除非股息明確表示為收回部分投資成本。在此情況下，倘股息與按公平值計入其他全面收益計量的投資有關，則股息於其他全面收益確認。然而，投資可能需相應進行減值測試。

2.30 Leases

As the lessee

Leases in which a significant portion of the risks and rewards of ownership are retained by the lessor are classified as operating leases. Payments made under operating leases (net of any incentives received from the lessor) are charged to the consolidated statement of profit or loss on a straight-line basis over the period of the lease.

The Group leases certain property, plant and equipment. Leases of property, plant and equipment where the Group has substantially all the risks and rewards of ownership are classified as finance leases. Finance leases are capitalised at the lease's commencement at the lower of the fair value of the leased property and the present value of the minimum lease payments.

Each lease payment is allocated between the liability and finance charges. The corresponding rental obligations, net of finance charges, are included in other long-term payables. The interest element of the finance cost is charged to the consolidated statement of profit or loss over the lease period so as to produce a constant periodic rate of interest on the remaining balance of the liability for each period. The property, plant and equipment acquired under finance leases is depreciated over the shorter of the useful life of the asset and the lease term.

As the lessor

A lease is an agreement whereby the lessor conveys to the lessee in return for a payment, or series of payments, the right to use an asset for an agreed period of time.

When assets are leased out under an operating lease, the asset is included in the balance sheet based on the nature of the asset.

Lease income on operating leases is recognised over the term of the lease on a straight-line basis.

2.30 租賃

作為承租人

倘租賃的絕大部分擁有權風險及回報均由出租人保留，則該等租賃分類為經營租賃。根據經營租賃作出的付款（已扣除從出租人獲得的任何優惠），於租賃期以直線法計入綜合損益表。

本集團出租若干物業、廠房及設備。如物業、廠房及設備的租賃擁有權所附的絕大部分風險及回報由本集團擁有，則有關物業、廠房及設備的租賃分類為融資租賃。融資租賃在租賃開始時按租賃物業之公平值及最低租賃付款現值兩者之較低者入賬。

每筆租金均分攤為負債及財務開支。相應租賃責任在扣除財務開支後計入其他長期應付款項內。財務費用的利息部分於租約期內在綜合損益表支銷，以就每個期間之負債餘額制定固定期間利率。根據融資租賃取得的物業、廠房及設備按資產之可用年期及租期兩者的較短者折舊。

作為出租人

租約為一份協議，據此出租人向承租人轉讓於協定期間內使用資產的權利，以交換一筆款項或一連串款項。

當資產根據經營租約租出，該項資產按資產性質計入資產負債表。

根據經營租約產生之租金收入以直線法於租賃期內確認。

2.31 Dividend distribution

Dividend distribution to the Company's shareholders is recognised as a liability in the Group's consolidated financial statements in the period in which the dividends are approved by the Company's shareholders or directors, where appropriate.

2.32 Government grants

Grants from the government are recognised at their fair value where there is a reasonable assurance that the grant will be received and the Group will comply with all attached conditions.

Government grants relating to costs are deferred and recognised in the consolidated statement of profit or loss over the period necessary to match them with the costs that they are intended to compensate.

3 FINANCIAL RISK MANAGEMENT

3.1 Financial risk factors

The Group's major financial instruments include trade and other receivables, fixed return investment, derivative financial assets, pledged bank deposits, cash and cash equivalents, trade and other payables, derivative financial liabilities and borrowings, etc. Details of the financial instruments are disclosed in Note 38.

The risks associated with these financial instruments include market risk (foreign exchange risk, interest rate risk and price risk), credit risk and liquidity risk. The policies on how to mitigate these risks are set out below. The management manages and monitors these exposures to ensure appropriate measures are implemented on a timely and effective manner.

2.31 股息分派

向本公司股東分派股息乃於股息經本公司股東或董事(如適用)批准期間在本集團綜合財務報表內確認為一項負債。

2.32 政府補助金

倘能合理確定將收取的補助及本集團將遵守所有附帶的條件,則按公平值確認政府補助金。

有關成本之政府補助均會於對應擬彌償成本所需之期間遞延並在綜合損益表確認入賬。

3 金融風險管理

3.1 金融風險因素

本集團的主要金融工具包括貿易及其他應收款項、固定回報投資、衍生金融資產、已抵押銀行存款、現金及現金等值項目、貿易應付款項及其他應付款項、衍生金融負債及借款等。該等金融工具詳情於附註38披露。

有關該等金融工具的風險包括市場風險(外匯風險、利率風險及價格風險)、信貸風險及流動資金風險。為減輕該等風險而制訂的政策載於下文。管理層管理及監控該等風險以確保及時有效地採取適當措施。

3.1 Financial risk factors (continued)

(a) Market risk

(i) Foreign exchange risk

The Group has foreign currency sales, purchases, trade, bills and other receivables, pledged bank deposits, cash and cash equivalents, trade, bills and other payables, derivative financial instruments, borrowings and amounts due from related parties which expose the Group to market risk arising from changes in foreign exchange rates. The Group currently does not have a specific foreign currency hedging policy. However, the management closely monitors its foreign currency risk exposure and considers any foreign currency forward contracts should the need arise.

In addition, the Group had entered into several foreign currency forward contracts with banks to reduce its exposure to currency fluctuation risk of payments for borrowings which were denominated in United States dollars ("US\$"). The derivatives were not accounted for under hedge accounting. The Group was required to estimate the fair value of the foreign currency forward contracts at the end of the reporting period, which therefore also exposed the Group to foreign exchange risk.

At 31 December 2018, if Renminbi ("RMB") had weakened/strengthened by 5% (2017: 5%) against the HK\$ or the US\$ with all other variables held constant, pre-tax profit for the year would have been HK\$25.0 million lower/higher (2017: HK\$55.4 million lower/higher), mainly as a result of foreign exchange losses/gains on translation of RMB/US\$ denominated trade, bills and other payables, borrowings, derivative financial instruments and cash and bank deposits.

3.1 金融風險因素(續)

(a) 市場風險

(i) 外匯風險

本集團因有外幣買賣、貿易、票據及其他應收款項、已抵押銀行存款、現金及現金等值項目、貿易、票據及其他應付款項、衍生金融工具、借款及應收關聯方款項而面對外匯匯率變動帶來的市場風險。本集團現時並無特定的外幣對沖政策。然而，管理層仍密切監控外幣風險，並會於需要時考慮任何外幣遠期合約。

此外，本集團與銀行訂立多項遠期外匯合約，以降低其因支付以美元（「美元」）計值的借款而面臨的貨幣波動風險。衍生工具未按對沖會計法列賬。本集團須於報告期末估計遠期外匯合約之公平值，由此導致本集團面臨其外匯風險。

於二零一八年十二月三十一日，倘人民幣（「人民幣」）兌港元或美元貶值／升值5%（二零一七年：5%），而所有其他參數保持不變，則年內除稅前溢利將減少／增加2,500萬港元（二零一七年：減少／增加5,540萬港元），主要由於換算以人民幣／美元計值之貿易、票據及其他應付款項、借款、衍生金融工具及現金及銀行存款之匯兌虧損／收益。

The credit risk of the Group mainly arises from cash and cash equivalents, derivative financial instruments, amounts due from related parties, fixed return investment, trade, bills and other receivables and deposits with banks and financial institutions. The carrying amounts of these balances represent the Group's maximum exposure to credit risk in relation to financial assets.

Credit risk is managed on a group basis. Management has policies in place to monitor the exposures to these credit risks on trade, bills and other receivables on an on-going basis.

To manage credit risk arising from cash and cash equivalents, derivative financial instruments, fixed return investment and deposits with banks and financial institutions, the Group only transacts with reputable and creditworthy commercial financial institutions and investment counterparties. The Group generally grants credit terms ranging from 30 to 90 days to customers upon the approval of management according to the credit quality of individual customers. The Group measures expected credit losses and applies lifetime expected loss allowances for all trade receivables. Details on the quantification in respect of the Group's exposure to credit risk on trade receivables are set out in Note 25.

Balances with related parties, bills and other receivables are considered to have low credit risk. These balances are continuously monitored by assessing the credit quality of the counterparties, taking into account its financial position, past experience and other factors.

At 31 December 2018, the Group had concentration of credit risk as 20% and 58% (2017: 16% and 53%) of its total trade receivables was due from its largest trade debtors and the five largest trade debtors respectively. Bank borrowings with a repayment on demand clause are included in the “on demand or less than 1 month” time band in the above maturity analysis. As at 31 December 2018, the aggregate carrying amounts of these bank borrowings amounted to HK\$233.8 million (2017: Nil). Taking into account the Group’s financial position, the directors do not believe that it is probable that the banks will exercise their discretionary rights to demand immediate repayment. The directors believe that such bank borrowings will be repaid within one year after the reporting date in accordance with the scheduled repayment dates set out in the loan agreements. At that time, the aggregate principal and interest cash outflows of HK\$234.6 million (2017: Nil) will be repaid within one year.

The amounts included above for the variable interest rate instruments are subject to change if changes in actual interest rates differ to those estimated at the end of the reporting period.

3.2 Capital management

The Group manages its capital to ensure that entities in the Group will be able to continue as a going concern while maximising the return to stakeholders through the optimisation of the debt and equity balance. The Group’s overall strategy remained unchanged from prior years.

The capital structure of the Group consists of debt, which includes bank and other borrowings disclosed in Note 31, net of cash and cash equivalents and equity attributable to shareholders of the Company, comprising capital, various reserves and accumulated losses.

4 CRITICAL ACCOUNTING ESTIMATES AND JUDGEMENTS

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are addressed below.

(a) Impairment of non-financial assets

The Group tests at least annually whether goodwill and other assets that have indefinite useful lives have suffered any impairment (Note 17). Other assets that are subject to depreciation and amortisation are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount of the asset exceeds its recoverable amount. The recoverable amounts of an asset or a cash-generating unit have been determined based on value-in-use calculations or its fair value less costs of disposal, whichever is higher. These calculations require the use of estimates. The value-in-use calculations primarily use cash flow projections. Judgement is required to determine key assumptions adopted in the cash flow projections and changes to key assumptions can significantly affect these cash flow projections and therefore the results of the impairment reviews.

估計及判斷經持續評估，並以過往經驗及其他因素為基礎，包括在現實情況下相信對未來事件的合理預期。

本集團會就未來作出估計及假設。由此產生之會計估計顯然很少與相關實際結果相符。具有重大風險於下一財政年度引致資產及負債賬面值之重大調整的估計及假設於下文載述。

(a) 非金融資產減值

本集團至少每年就商譽及其他沒有確定使用年期的資產進行測試，以確定是否出現減值（附註17）。其他需折舊及攤銷的資產則在當有事件出現或情況改變顯示賬面值超出其可收回金額時就減值進行檢討。資產或現金產生單位的可收回金額按照使用價值或其公平值減出售成本（以較高者為準）計算方法予以釐定。該等計算方法需要利用估算。使用價值計算方法主要使用現金流量預測。於現金流量預測中所採用的主要假設須作出判斷才能確定，主要假設的變化可能對此等現金流量預測產生重大影響，並最終影響減值檢討的結果。

4 CRITICAL ACCOUNTING ESTIMATES AND JUDGEMENTS (continued)

(b) Fair value of identifiable assets and liabilities acquired through business combinations and fair value of contingent consideration at the date of acquisition

The Group applies the acquisition method to account for business combinations, which requires the Group to record assets acquired and liabilities assumed at their fair values on the date of acquisition. Significant judgement and estimate are used to determine the completion date and fair value of the assets acquired and liabilities assumed. The valuation involves estimating future cash flows from the acquired business, determining appropriate discount rates, asset lives and other assumptions.

(c) Asset retirement obligations

Various pieces of land was leased by the Group for operating scrap yards and preparation of the land might be needed to make it appropriate for operated as scrap yards.

It was the Group's contractual obligation to bring the land to its original condition as the Group is not the owner of the land. The Group estimates the expected costs necessary to dismantle the scrap yards by assessing the discount rate as well as expected increment in future cost which might lead to changes in the provisions recognised.

(b) 透過業務合併收購的可識別資產及負債的公平值及於收購日期的或然代價公平值

本集團採用收購法將業務合併入賬，當中需要本集團按其於收購日期的公平值記錄已收購資產及已承擔負債，並採用重大判斷及估計，以釐定完成日期及已收購資產及已承擔負債的公平值。估值涉及估計收購所得業務之未來現金流量、釐定合適的貼現率、資產年期及其他假設。

(c) 資產報廢責任

本集團租用多幅土地營運廢料工場，因此需要將土地打造成適合營運廢料工場。

由於本集團並非土地的業主，因此本集團有合約責任須將土地恢復原貌。本集團透過評估貼現率及預測可能導致已確認撥備改變的未來成本增幅，估算清拆廢料工場所必需的估計成本。

(d) Estimation of provision for impairment of receivables

The loss allowances for receivables are based on assumptions about risk of default and expected loss rates. The Group uses judgement in making these assumptions and selecting the inputs to the allowances calculation, based on the Group's historical credit loss experience, existing market conditions as well as forward looking estimates at the end of each reporting period. Where the expectations are different from the original estimates, such differences will impact the carrying values of receivables and the impairment loss on receivable is recognised in the years in which such estimates have changed.

(e) Current and deferred income tax

The Group is subject to income taxes in numerous jurisdictions. Significant judgement is required in determining the worldwide provision for income taxes. There are many transactions and calculations for which the ultimate tax determination is uncertain, such as deductibility of compensation payments to customers. The Group recognises liabilities for anticipated tax audit issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences would impact the current and deferred income tax assets and liabilities in the period in which such determination is made.

Deferred tax assets relating to certain temporary differences and tax losses are recognised when management considers it is probable that future taxable profit will be available against which the temporary differences or tax losses can be utilised. Where the expectation is different from the original estimates, such difference will impact the recognition of deferred tax assets and income tax in the period in which such estimates are changed.

(d) 應收款項減值撥備之估計

應收款項虧損撥備乃按照有關違約風險及預期虧損率的假設計提。本集團在作出該等假設及篩選減值計算輸入數據時，根據本集團於各報告期末的歷史信貸虧損經驗、現有市況以及前瞻性估計作出判斷。當預期有別於原始估計時，該等差額將影響應收款項的賬面值，而應收款項減值虧損於有關估計已改變的年度內確認。

(e) 即期及遞延所得稅

本集團須繳付多個司法權區的所得稅。釐定世界各地的所得稅撥備時需要作出重大判斷。有諸多難以確定最終稅項的交易及計算方法，例如支付予客戶的補償的可扣稅程度。本集團根據估計會否有額外稅款到期而確認預測稅項審核事宜的負債。倘該等事宜的最終稅務結果與最初記賬的金額不同，有關差額將會影響作出有關決定期間的即期及遞延所得稅資產及負債。

倘管理層認為日後可能有應課稅溢利用作抵銷暫時差額及稅項虧損，則會確認有關若干暫時差額或稅項虧損的遞延稅項資產。倘預期與最初估計不同，則有關差額會影響估計更改期間的遞延稅項資產及所得稅確認。

(f) Net realisable value of inventories

Net realisable value of inventories is the estimated selling price in the ordinary course of business, less estimated cost to completion and selling expenses. Management of the Group reviews the inventories listing on a category-by-category basis at the end of the reporting period, and assesses whether the cost of the finished products will exceed their net realisable value. Management estimates the net realisable value for such inventories based primarily on the latest resale value and quoted prices on applicable commodity exchanges. If the market price of inventories are to decline, additional write down may be required. Management reassesses the estimation at the end of each reporting period.

(g) Fair value of derivatives and other financial assets

The fair value of financial instruments and other financial assets (including embedded derivative components of convertible bonds and options over shares in joint ventures to joint venture partners, if any) that are not traded in an active market is determined by using appropriate valuation techniques and making assumptions that are based on market conditions existing at each reporting date.

The fair value of options over shares of non-listed entities are determined using discounted cash-flow method, which requires the determination of an appropriate discount rate as well as assumptions regarding the cash-flow projections.

(f) 存貨之可變現淨值

存貨之可變現淨值為日常業務過程中的估計售價減估計完成成本及銷售開支。本集團管理層於報告期末按類別檢討存貨，並估計製成品的成本會否超逾可變現淨值。管理層主要按最新轉售價值及相關商品交易所報價估計有關存貨的可變現淨值。倘存貨市價下跌，則或須作出額外撇減。管理人員於各報告期末重新評估有關估計。

(g) 衍生工具及其他金融資產之公平值

並非於活躍市場買賣的財務工具及其他金融資產（包括可換股債券之嵌入式衍生部分及向合營企業合夥人發出之合營企業股份購股權（如有））之公平值乃透過採用適合估值方法及根據各報告日期存在的市況作出的假設釐定。

就非上市實體股份之購股權的公平值乃採用貼現現金流量法釐定，當中需要就現金流量預測釐定適當的貼現率以及假設。

4 CRITICAL ACCOUNTING ESTIMATES AND JUDGEMENTS (continued)

(h) Useful lives of property, plant and equipment and intangible assets

The Group's management determines the estimated useful lives and related depreciation and amortisation charges for its property, plant and equipment and intangible assets by reference to the estimated periods that the Group intends to derive future economic benefits from the use of these assets. These estimates are based on the historical experience of the actual useful lives of property, plant and equipment and intangible assets of similar nature and functions. Management will adjust useful lives as appropriate. Periodic review could result in a change in useful lives and therefore depreciation and amortisation expense in the future periods.

The Group has periodically reassessed useful lives of its property, plant and equipment, taking into consideration past usage and performance, prior repair and maintenance efforts, current physical and operating conditions of these assets, industry practices as well as future usage plans. Based on such assessment, the Group has applied a change in accounting estimate prospectively from 1 January 2018 arising from the reassessed useful lives of plant and machinery. As a result of the change in this accounting estimate, depreciation charge for the year ended 31 December 2018 and the net book value of property, plant and equipment as at 31 December 2018 has been decreased and increased by approximately HK\$46.0 million, respectively.

(h) 物業、廠房及設備以及無形資產的可使用年期

本集團管理層參考本集團擬自利用該等資產產生未來經濟利益的估計期間來釐定其物業、廠房及設備以及無形資產的估計可使用年期及有關折舊及攤銷費用。此等估計以相似性質及功能的物業、廠房及設備以及無形資產過往的實際可使用年期為基準。管理層將適時調整可使用年期。定期檢討可能導致可使用年期出現變動，因而產生未來期間的折舊及攤銷開支。

經考慮物業、廠房及設備的過往用途及表現、過往維修及保養投入、現時實質及營運狀況、行業慣例以及未來使用計劃，本集團已定期重行評估其該等資產的可使用年期。根據有關評估，本集團已自二零一八年一月一日起追溯應用重新評估廠房及機器的可使用年期產生的會計估計變動。由於該會計估計變動，截至二零一八年十二月三十一日止年度的折舊費用及物業、廠房及設備於二零一八年十二月三十一日的賬面淨值已分別減少及增加約4,600萬港元。

5 SEGMENT INFORMATION

The Group's revenue mainly represents the amounts received or receivable for the sales of metal scrap, net of sales related taxes, during the year. The Group derives revenue from transfer of these goods at a point in time.

There are differences in the basis of operating and reportable segments from the last annual consolidated financial statements.

After the acquisition of Scholz Holding GmbH ("Scholz Holding" and together with its subsidiaries "Scholz Group") in 2016, the management organised the Group and reviewed the Group's financial performance and allocated resources on a geographic basis, and hence, the operating and reportable segments were identified based on the location of the main operation of the legacy Group ("Greater China" region) and Scholz Group (Europe and North America, collectively known as "Non-Greater China" region).

From 2018 onwards, to better evaluate the Group's performance in each economic environment, management further divides the Non-Greater China region into the Europe region and the North America region. Also, in view of the plans for future business expansions in other Asian countries, the Greater China region has been renamed as Asia region. As a result, the operating and reportable segments of the Group now include Asia, Europe and North America regions.

In the current year, the Group's CODM assesses the performance of the operating segments based on the measure of segment profit. This measurement basis excludes the effects of non-operating gains/(losses), such as gain on bargain purchase on acquisition of subsidiaries, gain/(loss) on fair value change of financial assets at fair value through profit or loss. The measure also excludes centralised costs such as the Group's key managements' remunerations and other central administrative expenses. Finance income, finance costs, income tax expenses and those unallocated income and expenses are not included in the result for each operating segment that is reviewed by the Group's CODM.

The comparative segment information for the year ended 31 December 2017 and as at 31 December 2017 has been restated to align with the presentation of the current year's segment information disclosure.

與上一年度綜合財務報表的業務及可呈報分部基準存在差異。

於二零一六年收購Scholz Holding GmbH順爾茨控股有限公司*（「順爾茨控股」，並連同其子公司統稱「順爾茨集團」）後，管理層按地域組織、審視本集團的財務表現及分配資源，因此，業務及可呈報分部乃按固有集團（「大中華」地區）及順爾茨集團（歐洲及北美洲，統稱為「非大中華」地區）的主要營運位置來劃分。

自二零一八年起，為更好地評估本集團在各經濟環境中的表現，管理層進一步將非大中華地區劃分為歐洲地區及北美洲地區。此外，鑒於在其他亞洲國家的未來業務擴展計劃，大中華地區已更名為亞洲地區。因此，本集團的業務及可呈報分部現時包括亞洲、歐洲及北美洲地區。

於本年度，本集團的首席營運決策者根據分部溢利的計量評估經營分部的表現。此計量基礎不包括非經營收益／（虧損）的影響，例如於收購子公司之議價購買收益、按公平值計入損益之金融資產的公平值變動收益／（虧損）。計量亦不包括中央成本，例如本集團主要管理層的薪酬及其他中央行政開支。財務收入、財務成本、所得稅開支及該等未分配收入及開支並不包括在本集團的首席營運決策者所審閱的各個經營分部的業績中。

The Group operates a MPF Scheme for all qualifying employees in Hong Kong under the Mandatory Provident Fund Schemes Ordinance. The assets of the MPF Scheme are held separately from those of the Group, in funds under the control of an independent trustee. Under the rules of the MPF Scheme, the employer and its employees are each required to make contributions to the scheme at rates specified in the rules. The only obligation of the Group with respect of the MPF Scheme is to make the required contributions under the scheme. No forfeited contribution is available to reduce the contribution payable in future years.

The employees employed in the PRC are members of the state-managed retirement benefit schemes operated by the PRC government. On 29 November 2017, the Group and the joint venture partner of C.I.O.S.d.o.o ("CIOS") entered into a sale and purchase agreement in which the Group agreed to dispose its entire interest in CIOS as part of the consideration in exchange for 80% of DINOS.

Dinos is a metal recycler in Slovenia with 20% of its interest was directly held by one of the Group's subsidiaries, while 80% of its interest was held by CIOS prior to the transaction mentioned below.

Pursuant to the sale and purchase agreement, the Group agreed to acquire the remaining 80% interest of DINOS held by CIOS, in return, the Group transferred its entire 51.43% interest in CIOS to the joint venture partner. Furthermore, several other assets, including cash, other equity investments and receivables were transferred between both parties.

Subsequent to the transaction, DINOS became a wholly-owned subsidiary of the Group. The transaction is accounted for as a business combination achieved in stages. The Group remeasured its previously interest in DINOS on the date of acquisition which approximate its restated carrying value included in assets classified as held for sale.

The non-cash assets/liabilities transferred in return of the 80% interest of DINOS, including 51.43% interest in CIOS (without DINOS), certain amount due from/to related parties, other non-current assets, etc. were accounted for as the consideration transferred and remeasured at fair value at the date of acquisition. 45 CONTINGENCIES

- (a) The Company is a defendant to a legal claim by Delco regarding an alleged non-payment of the loan advanced by Delco Asia to subsidiaries of the Company, amounting to approximately HK\$57.8 million together with interest and costs. Delco alleged that it acquired the assets and liabilities of Delco Asia in 2011. Delco Asia was dissolved by deregistration in 2012. Each of Mr. Fang and HWH undertook to the Company to indemnify and hold the Company harmless on demand against all losses arising out of, inter alia, this claim in accordance with the terms of a letter of indemnity signed by Mr. Fang and HWH in favour of the Company on 17 December 2015 (the "Indemnity"). In addition, HWH has paid the amount of HK\$57.8 million to a lawyer in an escrow account ("Escrow Account") as security for any liability of the Company in respect of, inter alia, this claim.

The court case is still in progress. The directors of the Company, after taking legal advice from its legal advisers and in review of the Indemnity and the Escrow Account, are of the opinion that it is not probable that an outflow of resources embodying economic benefits will be required to settle this claim. Accordingly, no provision of this claim has been made.

- (b) The Company is a defendant to another legal claim by Delco regarding an alleged breach of a letter of undertaking in relation to a convertible bond issued by the Company and subscribed for by Delco. Delco further claimed against Chiho-Tiande (HK) limited ("CTHK") for a sum of US\$1.0 million, allegedly advanced by Delco Asia to CTHK. Delco further claimed interests, costs and further or other relief of HK\$6.3 million.

The court case is still in progress. The directors of the Company, after taking legal advice from its legal advisers, are of the opinion that it is not probable that an outflow of resources embodying economic benefits will be required to settle this claim. Accordingly, no provision of this claim has been made.

- (c) As at 31 December 2018, the Group has contingent liabilities of approximately HK\$27.4 million (2017: HK\$42.5 million) which consist of non-financial guarantee in favour of investee entities.
